

wq: Except for normal bypass flows after diversion and storage allocation has been met, or in case of emergency, we recommend no release of water from reservoir directly into stream channel leading to Battle Creek from July 1 to October 1. This will prevent high volumes of warm water from entering the creek during the summer months when native Ash will already be near their thermal limit.
