**Final Order**

*Appeal Rights*

This is a Final Order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This statement of judicial review rights does not create a right to judicial review of this order, if judicial review is otherwise precluded by law. Where no changes have been made to a Proposed Final Order on a water right application and no protests have been filed during the protest period, the Final Order is not subject to judicial review.

*Application History*

On December 27, 2010, Reds Cabin, LLC submitted an application to the Department for a water use permit. On September 7, 2011, the application was assigned to Daniel J Boyden Trust; Daniel J. Boyden, Trustee. The Department issued a Proposed Final Order on January 7, 2014. The protest period closed February 21, 2014, and no protest was filed.

The proposed use would not impair or be detrimental to the public interest.

**Order**

Application G-17446 therefore is approved as proposed by the Proposed Final Order, and Permit G-17158 is issued as limited by the conditions proposed by the Proposed Final Order.
