# Certificate of Water Right Ownership Update

### NOTICE TO SELLERS & BUYERS:

By law, all water belongs to the public (ORS 537.110). In almost every instance, a permit or water right certificate from the Water Resources Department is needed before using, diverting or storing water (ORS 537.130). However, most domestic wells do not require water rights. A certificate of water right stays with the land. In order to keep track of water right ownership, the Department requests that this form be submitted to the Department. *If for multiple rights, a separate form for each right will be required.* 

Water that has been used for a long time in one place or that involves a water structure (like a dam) that already exists is no guarantee that there is a water right which would allow the water use to continue.

Land in Malheur County, Oregon, as follows:

In Township 20 South, Range 47 East of the Willamette Meridian:

Section 7: A parcel of land in Government Lots 2 and 3 and in the SE1/4 NE1/4 more particularly described as follows:

Beginning at a point which is located North 00° 04' West, 471.8 feet from the Northwest corner of Lot 3, Section 8 of said Township and Range;

thence South 00° 04' East, 2119.3 feet;

thence North 66° 04' West, 366.8 feet;

thence North 09° 45' East, 2002.67 feet to the Point of Beginning.

Section 8: Government Lots 1, 2, 3 and 4,

EXCEPTING THEREFROM the following described parcel:

Beginning at a point which is located North 00° 04' West, 471.8 feet from the Southwest corner of said Lot 2; thence North 09° 45' East, 1817.79 feet;

The assessment roll and the tax roll disclose that the within described premises were specially assessed as farm land. If the land has become or becomes disqualified for the special assessment under the statute, an additional tax may be levied.

## CERTIFICATE OF WATER RIGHT

#### This Is to Certify, That

WALTER GEORGE DILLON

of P. O. Box 714, Hyssa , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Snake River

a tributary of Columbia River irrigation of 40.2 acres

Permit A-iM-5-64

for the purpose of

SP-12907-119

under Permit No. 29356 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Januery 6, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot  $l_1$  (SH<sub>4</sub> SW<sub>4</sub>), Section 8, T. 20 S., R. 17 E., W. H. Diversion point located 1320 feet South and 5520 feet East from the NW Corner. Section 7.

Corner, Section 7. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortisth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 1 acre feet per acre for each acre irrigated during the irrigation season of each year;

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
