This Extension of Time request is being processed in accordance with Oregon Administrative Rule Chapter 690, Division 315.

Please read this Proposed Final Order in its entirety as it contains additional conditions not included in the original permit.

This Proposed Final Order applies only to Permit G-8918, water right Application G-9861.

Summary of Proposed Final Order for Extension of Time

The Department proposes to:

- Grant an extension of time to complete construction from October 1, 2001 to October 1, 2050.
- Grant an extension of time to apply water to full beneficial use from October 1, 2001 to October 1, 2050.
- Make the extension of time subject to certain conditions as set forth below.

AUTHORITY

Generally, see ORS 537.630 and OAR Chapter 690 Division 315.

ORS 537.630(2) provides in pertinent part that the Oregon Water Resources Department (Department) may, for good cause shown, order and allow an extension of time, for the completion of the well or other means of developing and securing the ground water or for complete application of water to beneficial use. In determining the extension, the department shall give due weight to the considerations described under ORS 539.010 (5) and to whether other governmental requirements relating to the project have significantly delayed completion of construction or perfection of the right.

ORS 539.010(5) provides in pertinent part that the Water Resources Director, for good cause shown, may extend the time within which the full amount of the water appropriated shall be applied to a beneficial use. This statute instructs the Director to consider: the cost of the appropriation and application of the water to a beneficial purpose; the good faith of the appropriator; the market for water or power to be supplied; the present demands therefore; and the income or use that may be required to provide fair and reasonable returns upon the investment.

OAR 690-315-0080 provides in pertinent part that the Department shall make findings to determine if an extension of time for municipal and/or quasi-municipal water use permit holders may be approved to complete construction and/or apply water to full beneficial use.

Under specific circumstances, the Department may condition extensions of time for municipal water use permit holders to provide that use of the undeveloped portion of the permit maintains the persistence of listed fish species in the portions of the waterways affected by water use under the permit.

OAR 690-315-0090(3) authorizes the Department, under specific circumstances, to condition an extension of time for municipal and/or quasi-municipal water use permit holders to provide that diversion of water beyond the maximum rate diverted under the permit or previous extension(s) shall only be authorized upon issuance of a final order approving a Water Management and Conservation Plan under OAR Chapter 690, Division 86.

FINDINGS OF FACT

Background

- 1. Permit G-8918 was granted by the Department on August 25, 1980. The permit authorizes the use of up to 300 gpm of water, being 100 gpm from each of three wells, for municipal use. Well 1 (DOUG 53466) is within the Bushnell Creek Basin; and Well 2 (DOUG 53467) and Well 3 (DOUG 53468) are within the Clear Creek Basin. The permit specified that construction of the water development project was to be completed by October 1, 1981, and that complete application of water was to be made on or before October 1, 1982.
- 2. Four prior permit extensions have been granted for Permit G-8918. The most recent extension request resulted in the completion dates for construction and full application of water being extended to October 1, 2001.
- Due to an ongoing permit extension rulemaking, in 1998 the Department stopped processing pending Applications for Extension of Time for municipal and quasi-municipal permits, and did not require municipal and quasi-municipal water use permit holders to submit Applications for Extension of Time during the rulemaking process.
- 4. Municipal and quasi-municipal water use permit extension rules OAR 690-315-0070 through 690-315-0100 became effective on November 1, 2002. The rules were subsequently amended, and the amended rules became effective on November 22, 2005.
- 5. The permit holder, the City of Reedsport (City), submitted an "Application for Extension of Time" to the Department on July 21, 2003, requesting the time to complete construction and apply water to full beneficial use under the terms and conditions of Permit G-8918 be extended from October 1, 2001 to October 1, 2050.

- 6. Notification of the City's Application for Extension of Time for Permit G-8918 was published in the Department's Public Notice dated July 29, 2003. No public comments were received regarding the extension application.
- 7. On November 1, 2011, and July 25, 2014, the City submitted supplemental information and update revisions to their pending Application for Extension of Time.

Review Criteria for Municipal Quasi-Municipal Water Use Permits [OAR 690-315-0080(1)]

The time limits to complete construction and/or apply water to full beneficial use may be extended if the Department finds that the permit holder has met the requirements set forth under OAR 690-315-0080. This determination shall consider the applicable requirements of ORS 537.230 1 , 537.630 2 and/or 539.010(5) 3

Complete Extension of Time Application [OAR 690-315-0080(1)(a)]

8. On July 21, 2003, the Department received a completed Application for Extension of Time and the fee specified in ORS 536.050 from the permit holder.

Start of Construction [OAR 690-315-0080(1)(b)]

 Permit G-8918 was issued prior to June 29, 2005; therefore, the applicant is not required to provide evidence of actions taken to begin actual construction of the project.⁴

Duration of Extension [OAR 690-315-0080(1)(c) and (1)(d)]

Under OAR 690-315-0080(1)(c),(d), in order to approve an extension of time for municipal and quasimunicipal water use permits the Department must find that the time requested is reasonable and the applicant can complete the project within the time requested.

- 10. The remaining work to be accomplished under Permit G-8918 consists of completing construction including expansion of the water treatment plant, well field piping, and distribution connection piping; and applying water to full beneficial use.
- 11. As of October 1, 2001, the permit holder had appropriated 25 gpm of the 300 gpm, being 25 gpm of water from Well 3, authorized under Permit G-8918 for municipal purposes. There is an undeveloped portion of 275 gpm of water, being 100 gpm from Well 1 and 100 gpm from Well 2, and 75 gpm from Well 3, under Permit G-8918 as per OAR 690-315-0010(6)(g).

- 12. In addition to the 300 gpm authorized under Permit G-8918 (Wells 1, 2 and 3), the City holds the following municipal water rights:
 - Certificate 86045 for an amount not to exceed 10.19 cfs of water from Clear Lake, further limited to not to exceed 3200 AF of stored water per year [storage of water in Clear Lake and Clear Lake Reservoir from Clear Lake Watershed, a tributary of Clear Creek, authorized under Certificate 86000]; and
 - Permit S-14579 for 10.0 cfs of water from Clear and Edna Lakes & Reservoir [storage of 2500 AF of water from Clear Lake and 300 AF of water from Edna Lake, tributaries of Clear Creek, authorized under Permit R-755].
- 13. The city relies on water supplied from Clear Lake & Reservoir to meet its current demand. Water from Well #3 under Permit G-8918 currently supplies water in the Oregon Dunes National Recreation Area to park users. The intent in developing the three wells under Permit G-8918 is to serve as an back up / emergency water source for the of Reedsport serviced area should the Clear Lake source get contaminated.
- 14. According to the City, their peak water demand within its service area boundaries was 6.2 cfs in 2010.
- 15. The City's demand already exceeds the 300 gpm (0.66 cfs) of back up /emergency water that will be supplied under Permit G-8918. However, the City is requesting an extension until 2050, as this ground water source is a long term goal of the City due to cost constraints for planning, developing the well field, and completing the necessary distribution piping and treatment.
- 16. Full development of Permit G-8918 is needed to address the present and future water back up /emergency water supply needs.
- 17. The City's request for an extension of time until October 1, 2050, to complete construction and to apply water to full beneficial use under the terms and conditions of Permit G-8918 is both reasonable and necessary.

Good Cause [OAR 690-315-0080(1)(e) and (3)(a-q)and (4)]

The Department's determination of good cause shall consider the requirements set forth under OAR 690-315-0080(3) and OAR 690-315-0080(4).

Reasonable Diligence and Good Faith of the Appropriator [OAR 690-315-0080(3)(a),(3)(c) and (4)] Reasonable diligence and good faith of the appropriator must be demonstrated during the permit period or prior extension period as a part of evaluating good cause in determining whether or not to grant an extension. In determining the reasonable diligence and good faith of a municipal or quasi-municipal water use permit holder, the Department shall consider activities associated with the development of the right including, but not limited to, the items set forth under OAR 690-315-0080(4) and shall evaluate how well the applicant met the conditions of the permit or conditions of a prior extension period.

- 18. Prior to the issuance of Permit G-8918 on August 25, 1980, the City constructed Wells 1, 2 and 3.
- 19. Work was accomplished (specified in the Application for Extension of Time) during the original development time frame under Permit G-8918.
- 20. During the last extension period, being October 1, 1996 to October 1, 2001, the City made improvements to various water lines and installed the Scholfield pressure valve and the Bowman pump station.
- 21. Since the October 1, 2001, the City has made improvements to various transmission waterlines, various water systems, and various pump stations.
- 22. According to the City, as of July 21, 2003, they have invested approximately \$6,939,673, which is approximately 61 percent of the total projected cost for complete development of this project. The City estimates an additional \$4,519,104 investment is needed for the completion of this project. The Department recognizes that while some of these investment costs are unique to construction and development solely under G-8918, other costs included in this accounting are not partitioned out for G-8918 because (1) they are incurred under the development of a water supply system jointly utilized under other rights held by the City, and/or (2) they are generated from individual activities counted towards reasonable diligence and good faith as listed in ORS 690-315-0080(4) which are not associated with just this permit, but with the development and exercise of all the City's water rights.
- 23. As of October 1, 2001, of the 300 gpm authorized under Permit G-8918, 25 gpm has been appropriated from Well 3 for beneficial municipal purposes under the terms of this permit.
- 24. The Department has considered the City's compliance with conditions and did not identify any concerns.

Cost to Appropriate and Apply Water to a Beneficial Purpose [OAR 690-315-0080(3)(b)]

25. According to the City, as of July 21, 2003, they have invested approximately \$6,939,673, which is 61 percent of the total projected cost for complete development of this project. The City estimates an additional \$4,519,104 investment is needed for the completion of this project.

The Market and Present Demands for Water [OAR 690-315-0080(3)(d)]

26. As described in Findings 11 through 16 above, the City has indicated, and the Department finds that the City must rely on full development of their Permit G-8918 for its back up / emergency water supply.

- 27. Given the current water supply and demand situation of the City, there is a market and present demand for the water to be supplied as a backup / emergency source under G-8918.
- 28. OAR 690-315-0090(3) requires the Department to place a condition on this extension of time to provide that appropriation of any water from Well 1 (DOUG 53466) or Well 2 (DOUG 53467), and any water beyond 25 gpm from Well 3 (DOUG 53468) under Permit G-8918 shall only be authorized upon issuance of a final order approving a Water Management and Conservation Plan(s) (WMCP) under OAR Chapter 690, Division 86 which grants access to a greater appropriation of water under the permit consistent with OAR 690-086-0130(7). A "Development Limitation" condition" is specified under Item 1 of the "Conditions" section of this PFO to meet this requirement.

Fair Return Upon Investment [OAR 690-315-0080(3)(e)]

29. Use and income from the permitted water development project would likely result in reasonable returns upon the investment made in the project to date.

Other Governmental Requirements [OAR 690-315-0080(3)(f)]

30. Delays caused by any other governmental requirements in the development of this project have not been identified.

Events which Delayed Development under the Permit [OAR 690-315-0080(3)(q)]

31. Delay of development under Permit G-8918 was due, in part, to the size and scope of the municipal water system, which was designed to be phased in over a period of years.

Maintaining the Persistence of Listed Fish Species [OAR 690-315-0080(1)(f) and (2)]

The Department's determination regarding maintaining the persistence of listed fish species shall be based on existing data and advice of the Oregon Department of Fish and Wildlife (ODFW). The determination shall be limited to impacts related to stream flow as a result of use of the undeveloped portion of the permit and further limited to where, as a result of use of the undeveloped portion of the permit, ODFW indicates that stream flow would be a limiting factor for the subject listed fish species.

- 32. On August 6, 2003, the Water Resources Department determined under OAR Chapter 690 Division 9, that use of water under this ground water Permit G-8918 does not have the potential for substantial interference with surface water.
- 33. Based upon the Department's determination described in the above finding, the use of the undeveloped portion of Permit G-8918 does not have the potential for substantial interference with surface water, and therefore the persistence of listed fish species will be maintained.

CONCLUSIONS OF LAW

- 1. The City is entitled to apply for an extension of time to complete construction and/or completely apply water to the full beneficial use pursuant to ORS 537.630(2).
- 2. The City has submitted a complete extension application form and the fee specified under ORS 536.050(1)(k), as required by OAR 690-315-0080(1)(a).
- 3. Pursuant to Section 5, Chapter 410, Oregon Laws 2005, the permit holder is not required to demonstrate that actual construction of the project began within one year of the date of issuance of the permit, as otherwise required by OAR 690-315-0080(1)(b).
- 4. The time requested to complete construction and apply water to full beneficial use is reasonable, as required by OAR 690-315-0080(1)(c).
- 5. Completion of construction and full application of water to beneficial use can be completed by October 1, 2050⁵ pursuant to OAR 690-315-0080(1)(d).
- 6. The Department has considered the reasonable diligence and good faith of the appropriator, the cost to appropriate and apply water to a beneficial purpose, the market and present demands for water to be supplied, the financial investment made and the fair return upon the investment, the requirements of other governmental agencies, and unforeseen events over which the water right permit holder had no control, and the Department has determined that the City has shown good cause for an extension of time to complete construction and to apply the water to full beneficial use pursuant to OAR 690-315-0080(1)(e).
- 7. As required by OAR 690-315-0090(3) and as described in Finding 28, above, and specified under Item 1 of the "Conditions" section of this PFO, the appropriation of any water from Well 1 (DOUG 53466) or Well 2 (DOUG 53467), and any water beyond 25 gpm from Well 3 (DOUG 53468), under shall only be authorized upon issuance of a final order approving a Water Management and Conservation Plan(s) under OAR Chapter 690, Division 86 that authorizes access to a greater rate of appropriation of water under the permit consistent with OAR 690-086-0130(7).
- 8. Use of water under this ground water Permit G-8918 does not have the potential for substantial interference with surface water.

For permits applied for or received on or before July 9, 1987, upon complete development of the permit, you must notify the Department that the work has been completed and either: (1) hire a water right examiner certified under ORS 537.798 to conduct a survey, the original to be submitted as required by the Department, for issuance of a water right certificate; or (2) continue to appropriate water under the water right permit until the Department conducts a survey and issues a water right certificate under ORS 537.625.

Proposed Order

Based upon the foregoing Findings of Fact and Conclusions of Law, the Department proposes to issue an order to:

Extend the time to complete construction under Permit G-8918 from October 1, 2001 to October 1, 2050.

Extend the time to apply the water to beneficial use under Permit G-8918 from October 1, 2001 to October 1, 2050.

Subject to the following conditions:

CONDITIONS

1. **Development Limitations**

Appropriation of any water from Well 1 (DOUG 53466) up to 100 gpm or Well 2 (DOUG 53467) up to 100 gpm, and any water beyond 25 gpm from Well 3 (DOUG 53468) up to 100 gpm under Permit G-8918 shall only be authorized upon issuance of a final order approving a Water Management and Conservation Plan (WMCP) under OAR Chapter 690, Division 86 that authorizes access to a greater rate of appropriation of water under the permit consistent with OAR 690-086-0130(7). The required WMCP shall be submitted to the Department within 3 years of this Final Order. The amount of water used under Permit G-8918 must be consistent with this and subsequent WMCP's approved under OAR Chapter 690, Division 86 on file with the Department.

The deadline established in the Extension Final Order for submittal of a WMCP shall not relieve a permit holder of any existing or future requirement for submittal of a WMCP at an earlier date as established through other orders of the Department. A WMCP submitted to meet the requirements of the final order may also meet the WMCP submittal requirements of other Department orders.

Proposed Final Order Hearing Rights

- 1. Under the provisions of OAR 690-315-0100(1) and 690-315-0060, the applicant or any other person adversely affected or aggrieved by the proposed final order may submit a written protest to the proposed final order. The written protest must be received by the Water Resources Department no later than <u>September 19, 2014</u>, being 45 days from the date of publication of the proposed final order in the Department's weekly notice.
- 2. A written protest shall include:
 - a. The name, address and telephone number of the petitioner;
 - A description of the petitioner's interest in the proposed final order and if the protestant claims to represent the public interest, a precise statement of the public interest represented;
 - c. A detailed description of how the action proposed in the proposed final order would adversely affect or aggrieve the petitioner's interest;
 - d. A detailed description of how the proposed final order is in error or deficient and how to correct the alleged error or deficiency;
 - e. Any citation of legal authority supporting the petitioner, if known;
 - f. Proof of service of the protest upon the water right permit holder, if petitioner is other than the water right permit holder; and
 - g. The applicant or non-applicant protest fee required under ORS 536.050.
- 3. Within 60 days after the close of the period for requesting a contested case hearing, the Director shall:
 - a. Issue a final order on the extension request; or
 - b. Schedule a contested case hearing if a protest has been submitted, and:
 - 1) Upon review of the issues, the Director finds there are significant disputes related to the proposed agency action; or
 - 2) The applicant submits a written request for a contested case hearing within 30 days after the close of the period for submitting protests.
