A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

Permit G-12527 was issued by the Department on July 24, 1996, and modified by Permit Amendments T-10970 and T-11029 on November 18, 2010. The permit called for completion of construction by October 1, 1998, and complete application of water to beneficial use by October 1, 1999. The most recent extension authorized completion of construction and complete application of water to beneficial use by October 1, 2012. On March 14, 2013, Larry and Joan Sees and Michael and Eve Bechtholdt submitted to the Department an Application for

Extension of Time for Permit G-12527. In accordance with OAR 690-315-0050(2), on July 22, 2014, the Department issued a Proposed Final Order proposing to extend the time to complete construction to October 1, 2017, and the time to fully apply water to beneficial use to October 1, 2017, with the condition that this be the final extension approved for the permit. The protest period closed September 5, 2014, in accordance with OAR 690-315-0060(1). No protest was filed.

FINDINGS OF FACT

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated July 22, 2014.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, any comments received, and information within the file, the permit may be extended subject to the following conditions:

CONDITIONS

1. Last Extension Condition

This is to be the last extension of time granted for Permit G-12527. Any future extensions of time requests will be denied.

CONCLUSION OF LAW

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.630, 539.010(5) and OAR 690-315-0040(2).
