A request for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either file for judicial review, or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

Permit G-15351 was issued by the Department on March 31, 2003. The permit called for complete application of water to beneficial use by October 1, 2007. The most recent extension authorized complete application of water to beneficial use by October 1, 2013. On September 27, 2013, permit holder Interfor U.S. Inc. submitted to the Department an Application for Extension of Time for Permit G-15351, which was subsequently amended on September 17, 2014. In accordance with OAR 690-315-0050(2), on September 30, 2014, the Department issued a Proposed Final Order proposing to extend the time to fully apply water to beneficial use to October 1, 2018. The protest period closed November 14, 2014, in accordance with OAR 690-315-0060(1). No protest was filed.

FINDINGS OF FACT

ORDER

The extension of time for Application G-15109, Permit G-15351, therefore, is approved. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2013 to October 1, 2018.
