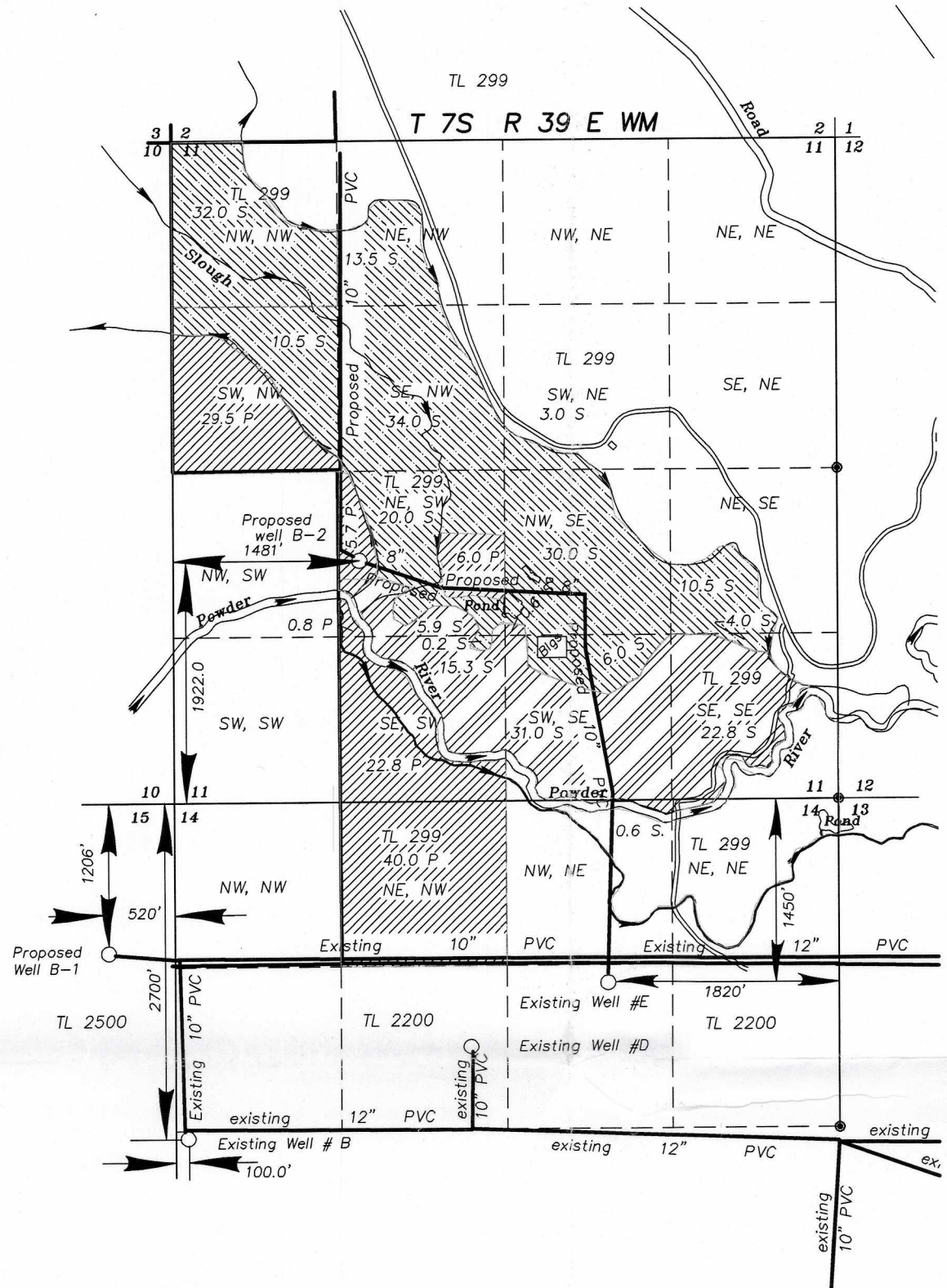

NOTE: It is the intention of Brad Allen to completely cover the lands lying within Section 11, North of Powder River to the North edge of C-82099. Mr. Allen intends to place primary lands in areas where Certificates 82099 and 64147 have gaps in the coverage, as I find discrepancies between the final proof maps and the certificates as to how many acres are being irrigated. One example is in the SW, NW. The final proof map show the area watered is 16.4 acres, which I agree with using aerial photos. Certificate 82099 only allows 10.5 acres with no explanation on the mapping as far as showing what acreage was allowed. I would guess the adjudication only allowed a lesser amount. It is not clear where the irrigated land is authorized and what is not authorized, as the maps differ from the written acres. I have shown the documented acres with the acres as written in the Certificates, but I also find that the area sometimes differs on the ground by as much as 6 acres. In some cases I have shown primary acres in larger amounts than my hatching indicates in order to fill the 40's to make up for the acres not mapped. I hope this is not too confusing. The end object is to fill up the 40's with water, unless I can see a reason the acres should be less. An example would be deducting the river from the irrigation.



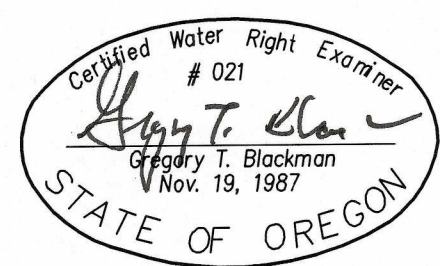
Proposed B-1 NE, NE Section 15, 7S R39E, W.M.; 1206 feet South and 520 feet West of NE Corner of Section 15.

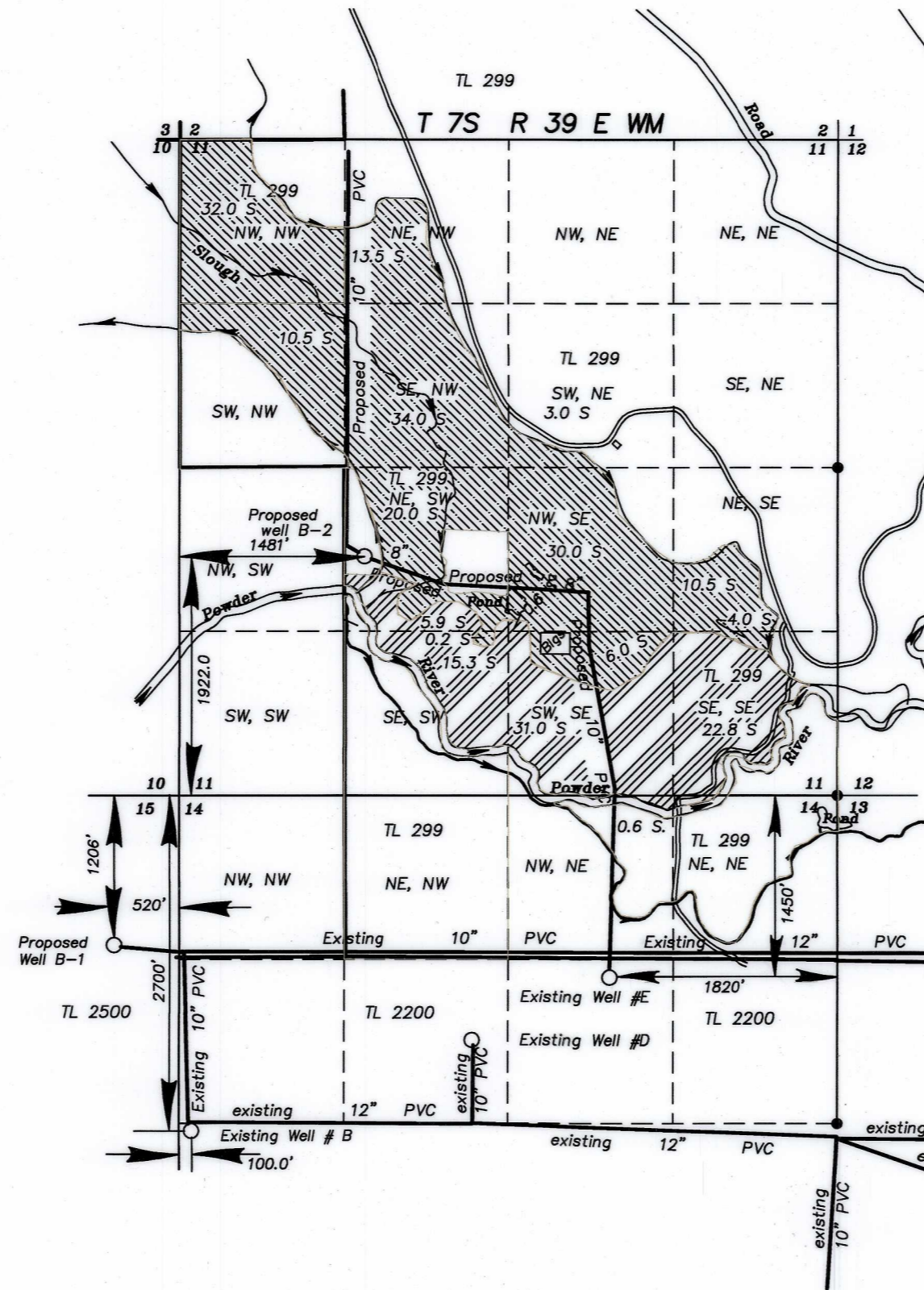

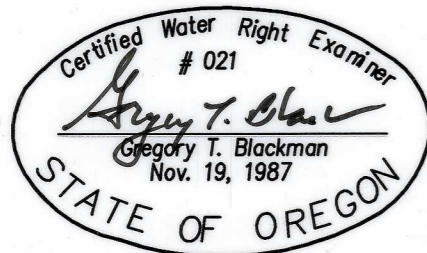
