Allensworth Donation land claim No. 46 in Section 17, Township 22 South, Range 8 West, N.W. bears north $13^{\circ} 08'$ East 164.4 Feet and running thence South $28^{\circ} 52'$ West 220.0 Feet to an iron rod.
