A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

Permit G-15297 was issued by the Department on December 20, 2002. The permit called for complete application of water to beneficial use by October 1, 2006. On May 21, 2015, Therese Sprauer and Abel Zavala submitted to the Department an Application for Extension of Time for Permit G-15297. In accordance with OAR 690-315-0050(2), on July 7, 2015, the Department issued a Proposed Final Order proposing to extend the time to fully apply water to beneficial use to October 1, 2016. The protest period closed August 21, 2015, in accordance with OAR 690-315-0060(1). No protest was filed.

The extension of time for Application G-15647, Permit G-15297, therefore, is approved. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2006 to October 1, 2016.
