A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

Permit G-14035 was issued by the Department on July 20, 2001. The permit specified for complete application of water to beneficial use by October 1, 2005. On June 11, 2015, Brian and Amy Kollman submitted to the Department an Application for Extension of Time for Permit G-14035. In accordance with OAR 690-315-0050(2), on July 28, 2015, the Department issued a Proposed Final Order proposing to extend the time to fully apply water to beneficial use to October 1, 2018. The protest period closed September 11, 2015, in accordance with OAR 690-315-0060(1). No protest was filed.

FINDINGS OF FACT

The extension of time for Application G-15133, Permit G-14035, therefore, is approved. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2005 to October 1, 2018.
