

Certificate of Water Right Ownership Update

NOTICE TO SELLERS & BUYERS:

By law, all water belongs to the public (ORS 537.110). In almost every instance, a permit **or** water right certificate from the Water Resources Department is needed before using, diverting or storing water (ORS 537.130). However, most domestic wells do not require water rights. A certificate of water right stays with the land. In order to keep track of water right ownership, the Department requests that this form be submitted to the Department. *If for multiple rights, a separate form for each right will be required.*

Water that has been used for a long time in one place or that involves a water structure (like a dam) that already exists is no guarantee that there is a water right which would allow the water use to continue.

EXHIBIT A

LEGAL DESCRIPTION: Real property in the County of Polk, State of Oregon, described as follows:

Beginning in the center of the Salem-Dallas Highway in Township 7 South, Range 4 West of the Willamette Meridian, Polk County, Oregon, at a point which is 100.00 feet Northeasterly along the center of the said Salem-Dallas Highway from a point which is equal distance from the intersection of the center line of Mud Creek with the center line of the Salem-Dallas Highway and the intersection of the center line of the said Salem-Dallas Highway with the East line of the Marcellus Dodson Donation Land Claim in the said Township and Range; thence Northeasterly along the center of the said Salem-Dallas Highway 150.00 feet; thence at right angles to the said Salem-Dallas Highway to the center of Rickreall Creek; thence Southwesterly along the center of the said creek to a line which is at right angles to the said Salem-Dallas Highway and passes through the point of beginning; thence Northerly at right angles to the said Salem-Dallas Highway to the point of beginning.
