#### Appeal Rights

A request for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either file for judicial review, or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

#### Application History

Permit G-15146 was issued by the Department on August 8, 2002. The permit called for complete application of water to beneficial use by October 1, 2006. On May 19, 2015, Bill and Willene Moore submitted to the Department an Application for Extension of Time for Permit G-15146. In accordance with OAR 690-315-0050(2), on August 18, 2015, the Department issued a Proposed Final Order proposing to deny the time to fully apply water to beneficial use to October 1, 2020. The protest period closed October 2, 2015, in accordance with OAR 690-315-0060(1). No protest was filed.

## **FINDINGS OF FACT**

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated August 18, 2015.

### **CONCLUSION OF LAW**

The applicant has not demonstrated good cause for the permit extension pursuant to ORS 537.630, 539.010(5) and OAR 690-315-0040(2).

#### **ORDER**

The extension of time for Application G-15507, Permit G-15146, therefore, is denied.
