RE: Request for Additional Time to Submit a Municipal Water Management and Conservation Plan for the City of Troutdale

Dear Mr. Schaffer:

We received a request from GSI Water Solutions, Inc., on behalf of the City of Troutdale (City), for additional time to finalize and submit the City's Water Management and Conservation Plan (WMCP). The additional time is necessary to allow the City sufficient time to finalize its internal reviews of the document, share the draft WMCP with affected local governments, and make additional revisions (*if necessary*).

Pursuant to OAR 690-086-0920, the request is granted. The new deadline for submittal of the WMCP is **March 31, 2016**.

In light of this approval for additional time to submit your WMCP, the Department would like to highlight how this could affect water use permit(s) you may hold.

- "Development Limitation" Conditions for Extended Water Use Permits

Please be aware that if access to water under a currently extended permit has been limited, (*as specified either under a final order extending the permit or in a final order approving a previous WMCP*), the diversion of any portion of the remaining undeveloped quantity of water allowed under the permit (*i.e., beyond the limitation*) may only be granted through the request in and approval of an updated WMCP [OAR 690-315-0090(3) and OAR 690-086-0915(4)].

- Certification of Water Use Permits

Failure to submit a WMCP required by a condition set forth in a water use permit may result in potential problems related to requesting certification of that water use permit.
