PUBLIC INTEREST PRESUMPTION; GROUNDWATER

OAR 690-310-130 (1) *The Department shall presume that a proposed groundwater use will ensure the preservation of the public welfare, safety and health as described in ORS 537.525.* Department staff review groundwater applications under OAR 690-310-140 to determine whether the presumption is established. OAR 690-310-140 allows the proposed use be modified or conditioned to meet the presumption criteria. **This review is based upon available information and agency policies in place at the time of evaluation.**

B3. **Groundwater availability remarks:** The applicant’s proposed POA will be producing from bedrock of volcanic origin that is part of the Early Western Cascades geologic terrane, likely Roxy Formation. Groundwater is found in fractures within the consolidated bedrock and the Rogue River likely represents the regional groundwater discharge point. The City of Shady Cove has ongoing issues/concerns with groundwater availability (related to low-yielding wells not over-appropriation) which has led to several OWRD observation wells in the vicinity. Water-level data from these wells show relatively stable long-term trends (see hydrograph below).

Basis for aquifer hydraulic connection evaluation: higher GW elevation suggests that groundwater is flowing toward and discharging to surface water; fractured nature of aquifer and high-relief terrain with incised, bedrock-lined river channels suggest that the Rogue River is a local groundwater discharge point.

Comments: Interference @ 30 d could not be estimated because the terrain (high-relief slopes) and geology (fractured bedrock aquifer) do not meet model assumptions of the widely accepted techniques for determining stream depletion (e.g., Hunt 1999, 2003).

C6. **SW / GW Remarks and Conditions:** The proposed POA will be producing from an aquifer that has been determined by the Department to be hydraulically connected to and within 1/4 mile of the Rogue River. OAR 690-009-0040 states that under these conditions the proposed use shall be assumed to have PSI. The application mentions a water contract from the Bureau of Reclamation for mitigation of impacts to surface water. Without mitigation the proposed groundwater use should not be allowed.

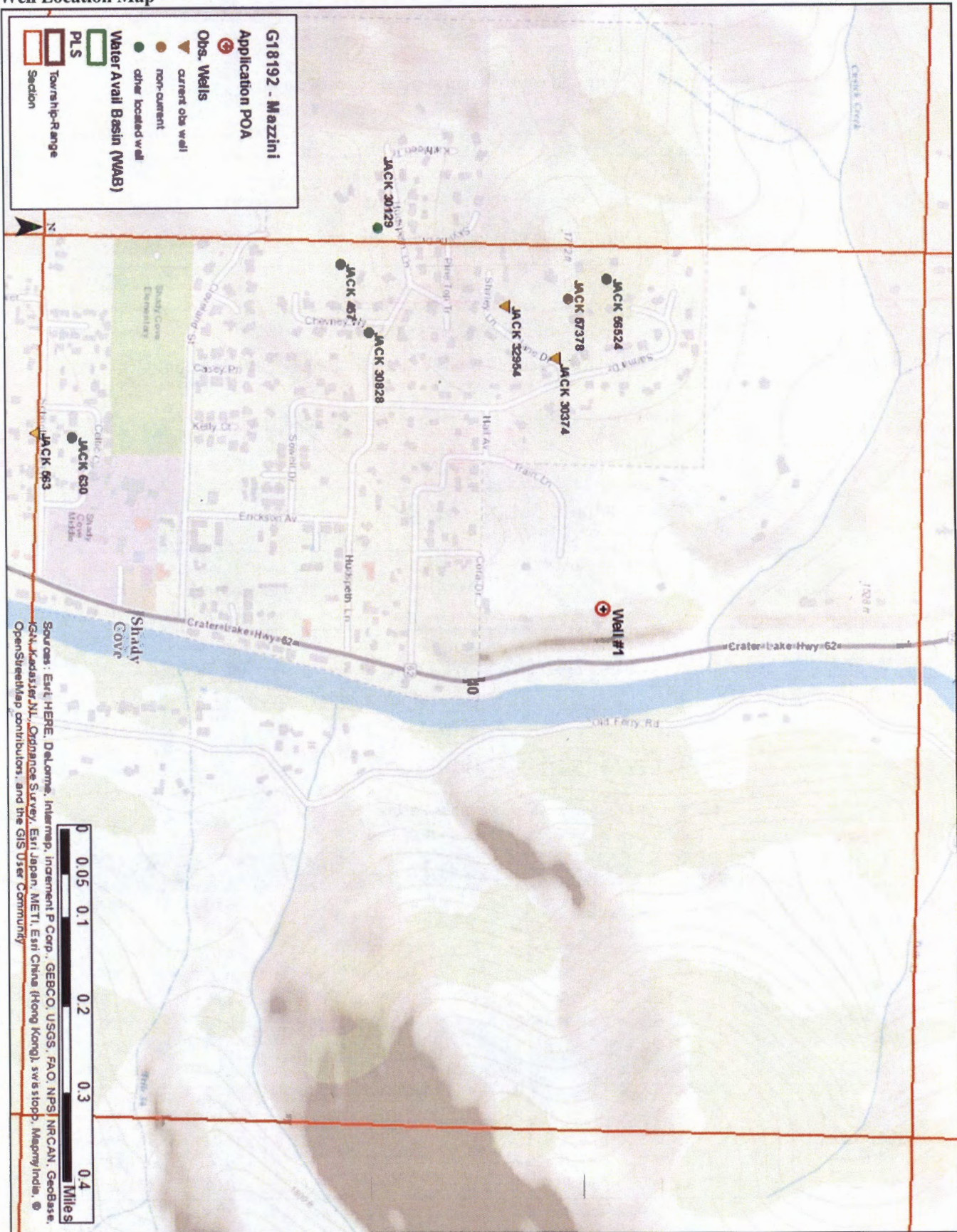
