The notice will give more information about WRD's water rights process and provide additional comment opportunities. Commencing at a 1 inch iron pipe monumenting the South Quarter corner of Section 8, Township 38 South, Range 4 West, Willamette Meridian, Jackson County, Oregon; thence North 820.71 feet to a 5/8 inch iron pin for the true point of beginning; thence North 40° 06' 50" East 50.00 feet to a 5/8 inch iron pin; thence South 30° 00' 00" East 231.26 feet to a 5/8 inch iron pin; thence South 89° 29' 10" East 1152.15 feet to a 5/8 inch iron pin; thence continue South 89° 29' 10" East 20 feet, more or less, to intersect the East boundary line of the Southwest Quarter of the Southeast Quarter of said Section 8; thence North along said East boundary 660 feet more or less, to the Northeast corner of said Quarter-Quarter; thence West along the North boundary of said Quarter-Quarter 1320 feet, more or less, to a point that bears North of the true point of beginning; thence South 20 feet, more or less, to a 5/8 inch iron pin witness corner; thence continue South 479.29 feet to the true point of beginning.
