

Certificate of Water Right Ownership Update

NOTICE TO SELLERS & BUYERS:

By law, all water belongs to the public (ORS 537.110). In almost every instance, a permit or water right certificate from the Water Resources Department is needed before using, diverting or storing water (ORS 537.130). However, most domestic wells do not require water rights. A certificate of water right stays with the land. In order to keep track of water right ownership, the Department requests that this form be submitted to the Department. If for multiple rights, a separate form for each right will be required.

Water that has been used for a long time in one place or that involves a water structure (like a dam) that already exists is no guarantee that there is a water right which would allow the water use to continue.

Bargain And Sale Deed

KNOW ALL MEN BY THESE PRESENTS: That Southern Pacific Industrial

Development Company, A Texas Corporation Grantor, in consideration of \$ XXXXX -0paid to it, does hereby grant, bargain, sell and convey unto Tualatin

Hills Park and Recreation District

Grantee, and its successors and assigns, that certain real property, with the tenements, hereditaments, and appurtenances thereunto belonging or appertaining, situated in the County State of Oregon, and more particularly described in Exhibit A, attached and Washington hereby made a part hereof, subject to easements, covenants, conditions, reservations and restrictions of record.
