Certificate of Water Right Ownership Update

NOTICE TO SELLERS & BUYERS:

By law, all water belongs to the public (ORS 537.110). In almost every instance, a permit or water right certificate from the Water Resources Department is needed before using, diverting or storing water (ORS 537.130). However, most domestic wells do not require water rights. A certificate of water right stays with the land. In order to keep track of water right ownership, the Department requests that this form be submitted to the Department. *If for multiple rights, a separate form for each right will be required.*

Water that has been used for a long time in one place or that involves a water structure (like a dam) that already exists is no guarantee that there is a water right which would allow the water use to continue.

CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MRS. SAM OBERG
4930 KINGS VALLEY HIGHWAY
DALLAS, OREGON 97338

confirms the right to use the waters of FERN CREEK AND OBERG FLASHBOARD DAM RESERVOIR CONSTRUCTED UNDER PERMIT R-5787, a tributary of LITTLE LUCKIAMUTE RIVER, for the purpose of IRRIGATING 80.4 ACRES.

The right has been perfected under Permit 40807. The date of priority is JUNE 21, 1976. The right is limited to not more than 1.0 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 52, SECTION 19,
T 8 S, R 5 W, W.M.; 670 FEET NORTH AND 800 FEET EAST FROM W 1/4 CORNER
SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under R-5785.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
