

# Certificate of Water Right Ownership Update

### NOTICE TO SELLERS & BUYERS:

By law, all water belongs to the public (ORS 537.110). In almost every instance, a permit or water right certificate from the Water Resources Department is needed before using, diverting or storing water (ORS 537.130). However, most domestic wells do not require water rights. A certificate of water right stays with the land. In order to keep track of water right ownership, the Department requests that this form be submitted to the Department. If for multiple rights, a separate form for each right will be required.

Water that has been used for a long time in one place or that involves a water structure (like a dam) that already exists is no guarantee that there is a water right which would allow the water use to continue.



Beginning at the quarter Section corner between Sections 2 and 11, in Township 9 South, Range 1 West of the Willamette Meridian, Marion County, Oregon; thence North along the quarter Section line of Section 2, 21.00 chains to the Southwest corner of the one acre conveyed by John Grier and wife to the Directors of School District No. 77 for a public burying ground by Deed recorded November 26, 1879, in Book 24, Page 340, Deed Records, thence East along the South line of said tract, 2.33 chains to the Southeast corner of said tract; thence North 5.00 chains to the Northeast corner of said tract; thence West 2.33 chains to said quarter Section line; thence North along said line, 3.25 chains to the Southwest corner of a 60.00 acre tract, conveyed to Alois Hassler and wife by Deed recorded May 9, 1919 in Book 150, Page 308, Deed Records; thence East along the South line of said tract, 160.00 rods to the Southeast corner; thence North on the East line of said tract 60.00 rods, more or less, to the North line of the Pelix M. Taylor and wife Donation Land Claim; thence East along said line 40.00 chains to the Northeast corner of said Donation Land Claim; thence South along the East line of said Donation Land Claim 177.00 rods to the Southeast corner of said Donation Land Claim; thence West 320.00 rods to the place of beginning.
