

## Certificate of Water Right Ownership Update

## NOTICE TO SELLERS & BUYERS:

By law, all water belongs to the public (ORS 537.110). In almost every instance, a permit **or** water right certificate from the Water Resources Department is needed before using, diverting or storing water (ORS 537.130). However, most domestic wells do not require water rights. A certificate of water right stays with the land. In order to keep track of water right ownership, the Department requests that this form be submitted to the Department. If for multiple rights, a separate form for each right will be required.

Water that has been used for a long time in one place or that involves a water structure (like a dam) that already exists is no guarantee that there is a water right which would allow the water use to continue.

## **EXHIBIT "A"**

Beginning at the Southwest corner of a 52.25 acre tract of land described in that certain deed from C.W. Corby to Grant Corby, March 14, 1887 in Volume 34, page 351, Marion County Deed Records, which point of beginning is on the South line of the J. H. Baughman and wife Donation Land Claim in Section 22, Township 5 South, Range 1 West of the Willamette Meridian, Marion County, Oregon; thence East, along the South line of said Donation Land Claim, 16.118 chains, more or less, to the center line of a road running in a Northerly direction through said Donation Land Claim; thence North, along the center line of said road, 18.81 chains to the Southeast corner of a certain 15.52 acre tract of land described in deed to Arthur E. Hughes, et ux, recorded March 17, 1925 in Volume 180, page 359, Deed Records; thence West, along the South line of said Hughes tract, 16.118 chains to the Southwest corner of said Hughes tract, which is also the most Westerly Northwest corner of the aforesaid Corby tract; thence South, along the West line of said Corby tract, 18.81 chains to the place of beginning, being situated in Section 22, Township 5 South, Range 1 West of the Willamette Meridian, Marion County, Oregon.
