

The North 725.0 feet when measured along the East line of the following:

Beginning at a point on the South edge of the right of way of the Butte Falls Road which is marked by a galvanized iron pipe, and which is approximately 1010.0 feet South of the quarter corner common to Sections 27 and 34 in Township 34 South, Range 1 East of the Willamette Meridian in Jackson County, Oregon; thence South 1450.0 feet to a point on the North and South center line of said Section 34; thence West 545.0 feet; thence North 4°55' East 1558.7 feet to a point on the South edge of the right of way of the Butte Falls Road; thence Southeasterly, along the edge of said right of way on the outside of a 3° curve, 421.5 feet, more or less, to the point of beginning.
