WATER RIGHT OWNERSHIP UPDATE FORM

NOTICE TO SELLERS & BUYERS:

By law all water belongs to the public (ORS 537.110). In almost every instance, a permit ("water right") from the Water Resources Department is needed before using, diverting, or storing any water (ORS 537.130). However, most domestic wells do not require water rights. A water right stays with the land. In order to keep track of water right ownership, ORS 537.330 requires persons selling property that has a water right to: 1) provide evidence of the water right to the buyer and 2) notify the Water Resources Department of the water right involved with the real estate transaction. Sellers are exempted from this requirement if the water uses are served by a water district or a city.

Water that has been used for a long time in one place or that involves a water structure (like a dam) that already exists is no guarantee that there is a water right which would allow the water use to continue.

CERTIFICATE OF WATER RIGHT

This is to Certify, That **HOLMES D. GLOVER**
of **Jordan Valley**, State of **Oregon** **97910** has a right to the use of
the waters of **Cow Creek for Tract #1; Mahogany Creek for Tract #2**
for the purpose of **Irrigation**

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Malheur County, and the said decree entered of record at Salem, in the Order
Record of the STATE ENGINEER, in Volume **9**, at page **1**; that the priority
of the right thereby confirmed dates from **1879 for Tract #1; December 5, 1887 for**
Tract #2

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed **2 acre feet per acre**
prior to June 1st, and 1/2 acre foot per acre during any calendar month after
June 1st, of each irrigation season from April 1st to October 15th

A description of the lands irrigated under such right, and to which the water is appurtenant
(or, if for other purposes, the place where such water is put to beneficial use), is as follows:

TRACT #1: 25.4 acres in NE1/4NE1/4, 40 acres in NW1/4NE1/4, 40 acres in SW1/4NE1/4, 4.7
acres in SE1/4NE1/4, 20 acres in NE1/4NW1/4, 25 acres in SE1/4NW1/4, 2.3 acres
in NE1/4SW1/4, 10 acres in NE1/4SE1/4, 11.4 acres in NW1/4SE1/4, 15 acres in
SE1/4SE1/4, Section 36, T. 28 S., R. 44 E., W.M., being a total of 193.8
acres.

TRACT #2: 12.5 acres in SW1/4NE1/4, 25.5 acres in NE1/4SW1/4, 20.8 acres in SE1/4SW1/4,
27.7 acres in SW1/4SW1/4, 25 acres in NW1/4SE1/4, 2.5 acres in SE1/4NW1/4,
Section 30, 11.2 acres in NW1/4NW1/4 (Lot 1), Section 31, T. 28 S., R. 45
E., W.M., being a total of 125.2 acres.

And said right shall be subject to all other conditions and limitations
contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place
of use herein described.

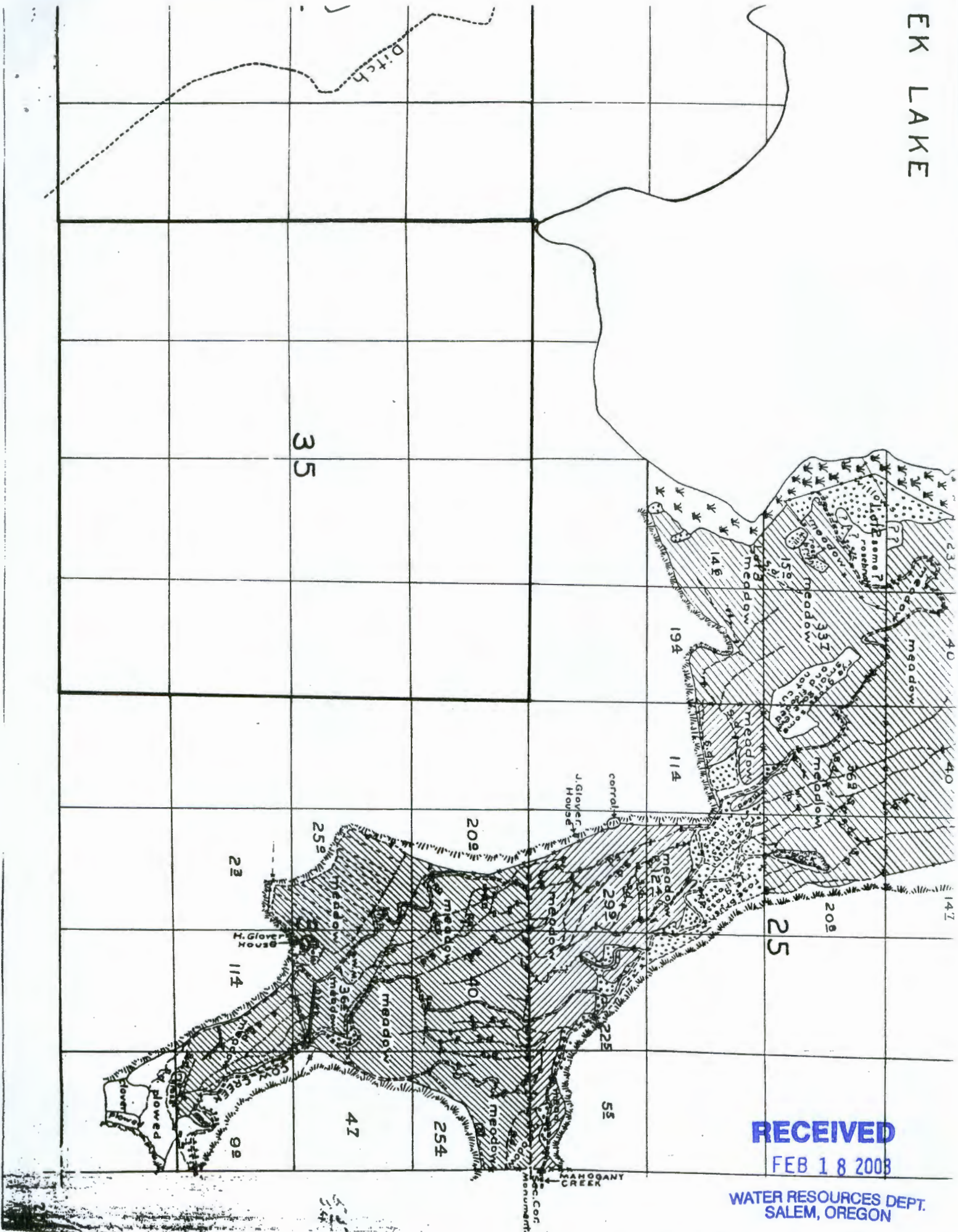

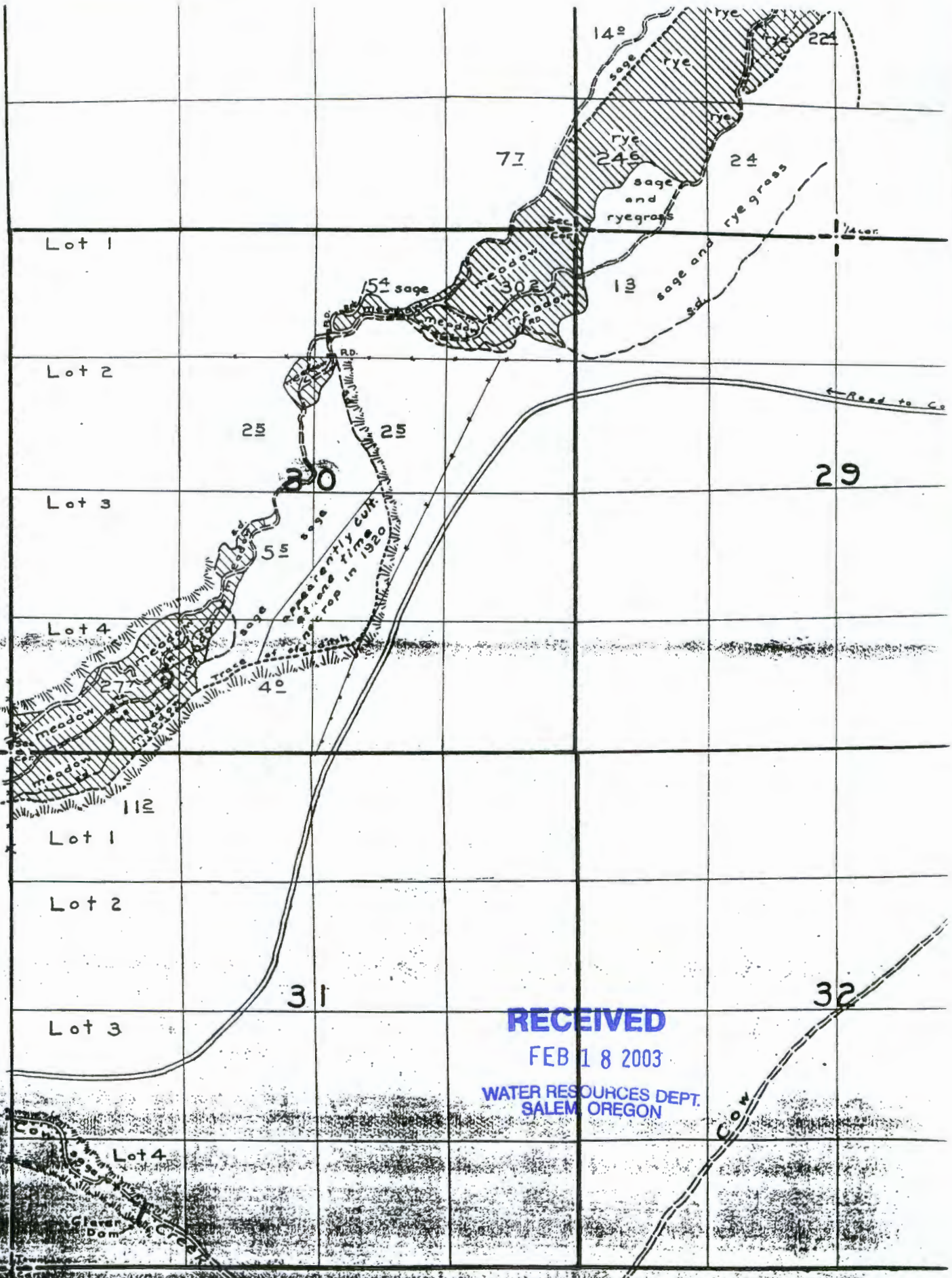
