## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** ARTHUR L. and HAZEL MAXWELL

of Antelope, State of Oregon, has a right to the use of the waters of Antelope Creek and Grub Hollow Creek

a tributary of Trout Creek and Antelope Creek for the purpose of irrigation of 29.75 acres, domestic and stock use and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jefferson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 5, at page 57; that the priority of the right thereby confirmed dates from 1901 for irrigation and 1873 for stock use for Tract No. 1; 1895 for Tract No. 3

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.00 acre foot per acre during any period of 30 days or 3 acre feet per acre during any irrigation season, and shall be subject to all other conditions and limitations contained in said decree.

The point of diversion is located in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 32, T. 7 S., R. 17 E., W. M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

Tract No. 1 from Antelope Creek

7.5 acres NW $\frac{1}{4}$  SE $\frac{1}{4}$

10.5 acres SW $\frac{1}{4}$  SE $\frac{1}{4}$

Tract No. 3 from Grub Hollow Creek

Certificate of water right issued to H. B. Taylor and recorded at page 2261, Volume 3, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 39.75 acres, domestic and stock use. Subsequently, the right to the use of water appurtenant to 10.0 acres, domestic and stock use was canceled by order of the State Engineer entered January 7, 1969. This certificate is issued to confirm the remaining right to the use of water for irrigation, domestic and stock use and supersedes the certificate heretofore issued to H. B. Taylor.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
