PUBLIC INTEREST PRESUMPTION; GROUNDWATER

OAR 690-310-130 (1) *The Department shall presume that a proposed groundwater use will ensure the preservation of the public welfare, safety and health as described in ORS 537.525.* Department staff review groundwater applications under OAR 690-310-140 to determine whether the presumption is established. OAR 690-310-140 allows the proposed use be modified or conditioned to meet the presumption criteria. **This review is based upon available information and agency policies in place at the time of evaluation.**

Nearby wells report production from water-bearing zones within bedrock at similar depths as those encountered within this well.

Basis for aquifer confinement evaluation: Proposed POA MALH 1773 is cased and sealed 5 feet into a 44 foot thick section "black rock". Well logs from nearby sections also report "black basalt" at similar elevations, confirming that this unit exists and is laterally continuous for some distance.

Basis for aquifer hydraulic connection evaluation: Nearby wells with similar depth and construction report the productive water-bearing zone in basalt at elevations about 100 feet below the elevation of the Malheur River. Lava flows in this area appear to be laterally continuous, and there are no springs mapped within 1 mile that would indicate discharge to the Malheur River from this deeper confined aquifer system.

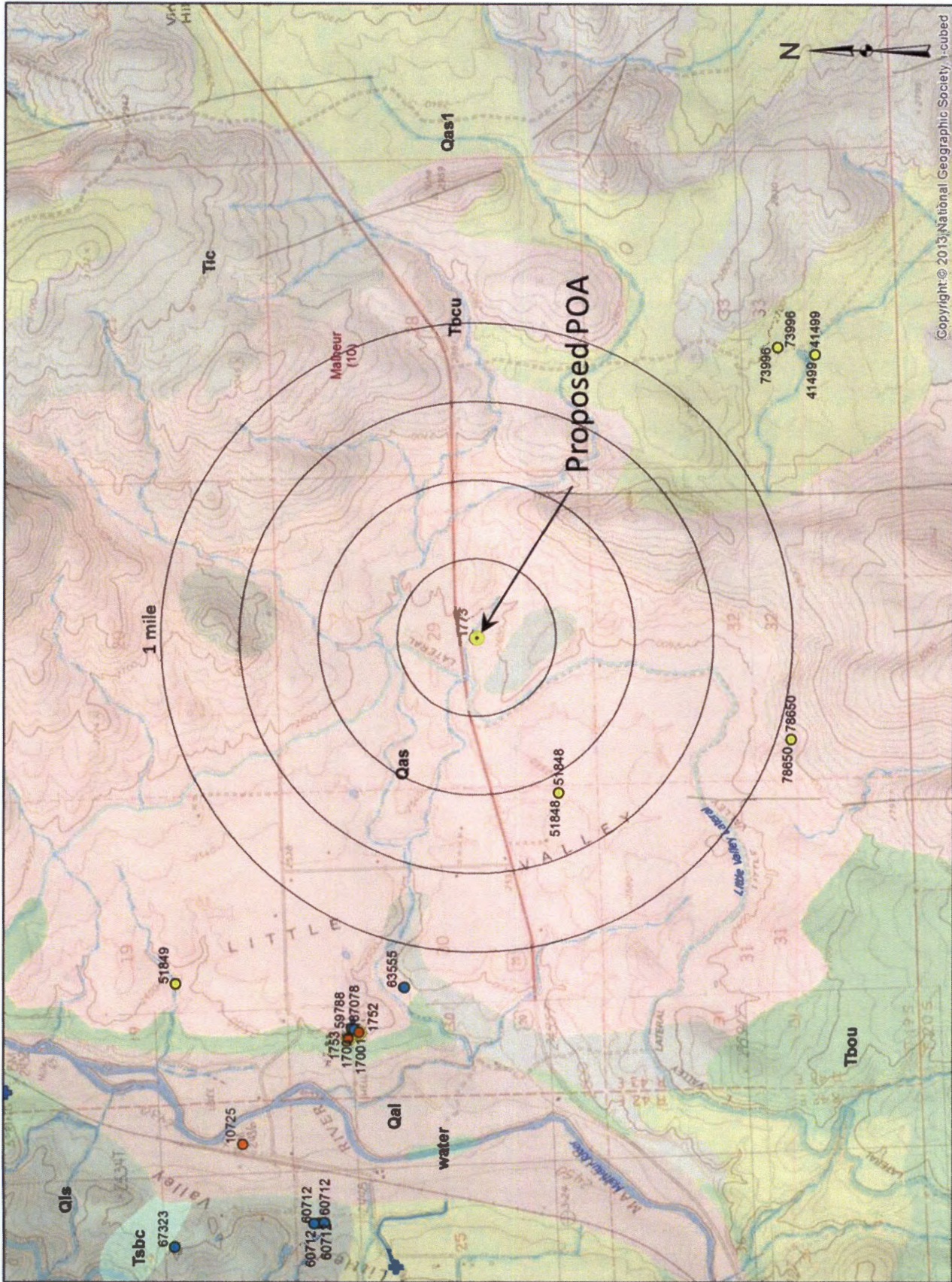

Well Location Map

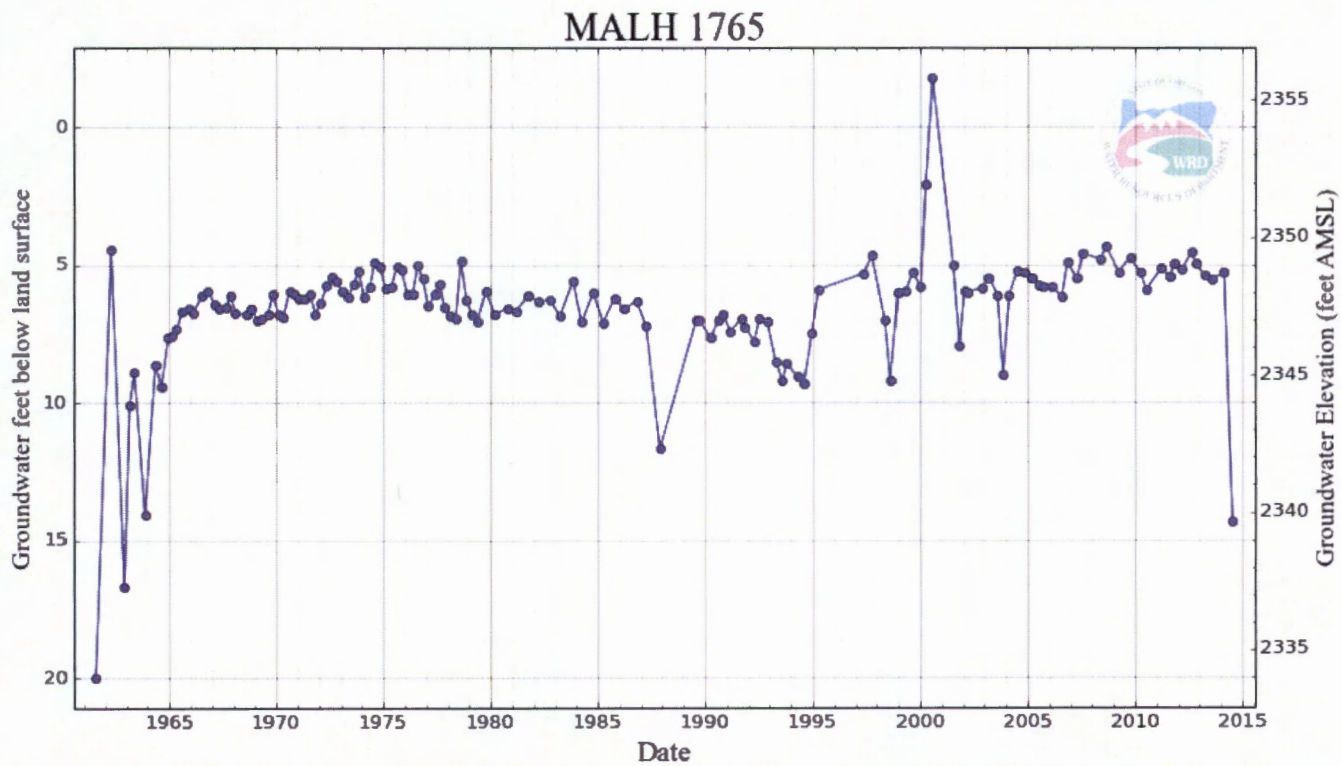

State Obs Well MALH 1765, 4.6 miles to the north of proposed POA MALH 1773, showed about 10 feet of decline during the drought of 2014. MALH 1765 is open to both unconfined alluvium and deeper bedrock lithologies.
