Pursuant to ORS 536.075 and OAR 137-004-0080 you may either file for judicial review, or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

Permit G-15937 was issued by the Department on July 21, 2005. The permit called for complete application of water to beneficial use by October 1, 2009. On January 27, 2016, Fernando Benitez Diaz, submitted an Application for Extension of Time for Permit G-15937. In accordance with OAR 690-315-0050(2), on May 17, 2016, the Department issued a Proposed Final Order proposing to extend the time to fully apply water to beneficial use From October 1, 2009 to October 1, 2020. The protest period closed July 1, 2016, in accordance with OAR 690-315-0060(1). No protest was filed.

FINDINGS OF FACT

The extension of time for Application G-16094, Permit G-15937, therefore, is approved. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2009 to October 1, 2020.
