CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN NOBLE  
ROUTE 1, BOX 198  
DAYTON, OREGON 97114

confirms the right to use the waters of THE WILLAMETTE RIVER, a tributary of THE COLUMBIA RIVER, for SUPPLEMENTAL IRRIGATION FOR 49.4 ACRES.

This right was perfected under Permit 47677. The date of priority is JULY 6, 1983. This right is limited to 0.62 CUBIC FOOT PER SECOND CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 25, T 5 S, R 3 W, W.M.; 1600 FEET SOUTH AND 1040 FEET EAST FROM THE NW CORNER OF SECTION 25.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land provided further that although declared herein to be for supplemental irrigation the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
