Water-Use Permit Application Processing

1. Completeness Determination

The Department evaluates whether the application and accompanying map contain all of the information required under OAR 690-310-0040 and OAR 690-310-0050 (www.oregon.gov/owrd/law.oar). The Department also determines whether the proposed use is prohibited by statute. If the Department determines that the application is incomplete, all fees have not been paid, or the use is prohibited by statute, the application and all fees submitted are returned to the applicant.

2. Initial Review

The Department reviews the application to determine whether water is available during the period requested, whether the proposed use is restricted or limited by rule or statute, and whether other issues may preclude approval of or restrict the proposed use. An Initial Review (IR) containing preliminary determinations is mailed to the applicant. The applicant has 14 days from the mailing date to withdraw the application from further processing and receive a refund of all fees paid minus \$200. The applicant may put the application on hold for up to 180 days and may request additional time if necessary.

3. Public Notice

Within 7 days of the mailing of the initial review, the Department gives public notice of the application in the weekly notice published by the Department at www.oregon.gov/owrd. The public comment period is 30 days from publication in the weekly notice.

4. Proposed Final Order Issued

The Department reviews any comments received, including comments from other state agencies related to the protection of sensitive, threatened or endangered fish species. Within 60 days of completion of the IR, the Department issues a Proposed Final Order (PFO) explaining the proposed decision to deny or approve the application. A PFO proposing approval of an application will include a draft permit, and may request additional information or outstanding fees required prior to permit issuance.

5. Public Notice

Within 7 days of issuing the PFO, the Department gives public notice in the weekly notice. Notice includes information about the application and the PFO. Protest must be received by the Department within 45 days after publication of the PFO in the weekly notice. Anyone may file a protest. The protest filing fee is \$350.00 for the applicant and \$700.00 for non-applicants. Protests are filed on approximately 10% of Proposed Final Orders. If a protest is filed the Department will attempt to settle the protest but will schedule a contested case hearing if necessary.

6. Final Order Issued

If no protests are filed, the Department can issue a Final Order within 60 days of the close of the period for receiving protest. If the application is approved, a permit is issued. The permit specifies the details of the authorized use and any terms, limitations or conditions that the Department deems appropriate.

Place of Use Acreage

Port of Morrow and NOWA have indicated the full boundary where new water supplies from this permit may be used. Final place of use, as well as total primary and total supplemental acreages will be detailed prior to final proof survey.

Period of Use Division 33 Mitigation Proposed

Port of Morrow and NOWA proposes a period of use from March 1 to November 1 of each year. Water from the Columbia River will be subject to mitigation from April 15 to September 30. From March 1 to April 14 and from October 1 to November 1 of each year, NOWA may pump out of the Columbia River without the need for mitigation. NOWA proposes to secure mitigation at the appropriate level required by regulating agencies to pump Columbia River water from April 15 to September 30. Sources of mitigation will be documented and reported to OWRD prior to the start of the mitigation season and the pumping rate during the mitigation season will be directly proportionate to the mitigation secured. The period for mitigation requirements is currently 169 days of the period of use. NOWA has option agreements with mitigation water sources to have all mitigation to satisfy the max rate (23 cfs) for the maximum mitigation duration (169 days) in place by 2017.



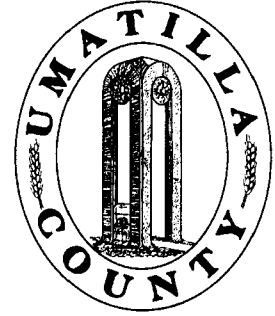

NOWA CENTRAL WATER DELIVERY PROJECT

Description of Proposed Central Project

General System Layout

The Northeast Oregon Water Association (NOWA) is proposing to divert 35 cubic-feet-per-second (cfs) of Columbia River water at a proposed new central pump station located approximately 1 mile west of Umatilla, Oregon in the John Day Pool of the Columbia River. The new pump station would be co-located with an existing agricultural pump station (Amstad Farms). A pipeline would run from the new pump station approximately south for a total of approximately 5 miles, either terminating to atmosphere at an existing overflow pond owned and operated by Westland Irrigation District (WID) or terminating at the WID A-Line canal. Water that is diverted during the irrigation season would be delivered to the WID overflow pond or the A-Line canal, and then conveyed by WID to authorized places of use. An Aquifer Recharge option is also being considered for the same system during the non-irrigation months, but any such use would be included in a separate water right application. The entire system would share the Amstad Farms intake screen (fish screen) and pipeline, but a new pump station would be necessary. The pipeline route was determined based on communications between NOWA and interested landowners.

The only major obstacles for the pipeline include crossings of Highway 730 and the West Extension Irrigation District (WEID) canal. There are a few other minor farm crossings that could be completed without boring.

Pump Stations

The system as proposed requires a new pump station on the Columbia River. The pump station would be located adjacent to the existing Amstad Farms pump station. The System would share Amstad Farms' intake screen and pipeline. The shared portion of the intake would be purchased or leased from Amstad Farms. The Amstad Farms intake screen and manifold will allow for 35 cfs of capacity beyond the maximum pumping rate for current water rights. It is anticipated that during periods when Amstad Farms is not pumping at its full capacity that

additional capacity in the intake may be leased, up to a total of 45 cfs for the new system. The new pipeline as proposed would have a capacity of 45 cfs.

The new Columbia River pump station would have a total capacity of 45 cfs (20,196 gpm) at a total head of 470 feet. The river pump station would require an upgrade to the electrical substation that currently serves Amstad Farms. The system should not require any booster pumps to convey water from the Columbia River pump station to the pipeline termination to atmosphere or the WID A-Line canal. Construction completion is estimated to take place prior to the 2015 irrigation season.

Conveyance Infrastructure and Points of Delivery

The pipeline would consist mostly of 42-inch diameter PVC pipe with the first approximately 2,300 feet of the pipeline consisting of steel due to pressure requirements. The pipeline would reach its peak elevation about 9,400 feet before the A-Line (WID) overflow pond. Based upon this downhill travel, the pipeline would be downsized to 36 inches in diameter because of excess available pressure. If the system is intended to be purely pressurized in the future, it may be advantageous to increase the pipeline diameter to 42 inches, which would be designed to conserve pressure. If it is intended to be a discharge to atmosphere, there will be approximately 50 psi of pressure available that could be used for in-line hydroelectric generation. This option is being explored but is not under consideration as part of the current water right permit application.

Eastern Oregon communities are all centered on agriculture. With the abundant sunshine and the long growing season, the region is considered prime farm ground. With the variety of crops that are grown in the area, it allows numerous food processing facilities to be based here providing employment for many citizens. The output of their product is shipped around the state for further processing providing jobs for other areas in Oregon. The thriving communities in Eastern Oregon all depend on agriculture to provide them with a living wage. The basis for agriculture that keeps this area alive is water.

Many excellent quality high value crops are grown in the area by using Good Agricultural Practices. This entails taking care of the soil all year round instead of only when there is a crop planted.

In the fall it is considered a Good Agricultural Practice to plant a cover crop to shelter the soil through the winter until planting the following spring. This practice is used to suppress weeds by choking them out, and reduces soil water evaporation by increasing shade. Cover crops also improve soil health by creating channels in the soil with the plant's roots, and reduces soil erosion caused by wind and water runoff. A cover crop can consume upwards of 3 to 4 inches of water depending on the time of year it is planted.

Before tillage and planting can occur, there needs to be an optimal amount of moisture available in the soil. Our primary soil type in the region is the sandy loam. If the sandy loam does not have enough moisture, the equipment will be unable to produce the desired effects that are needed from tillage. Optimal amount of moisture needs to be in place for the seeds to germinate. After planting has occurred, 1 to 2 inches of water is typically irrigated on the field in order to achieve prime germination.

Crop water needs vary by plant variety, but one thing is true for all plants; they need the right amount of water at key stages of plant growth in order to produce a viable product. In this area, water usage can range from 36 to 40 inches of water per season for high quality food output.

With these Good Agricultural Practices in place in the area, it can take upwards of 38-42 inches of irrigation a year.
