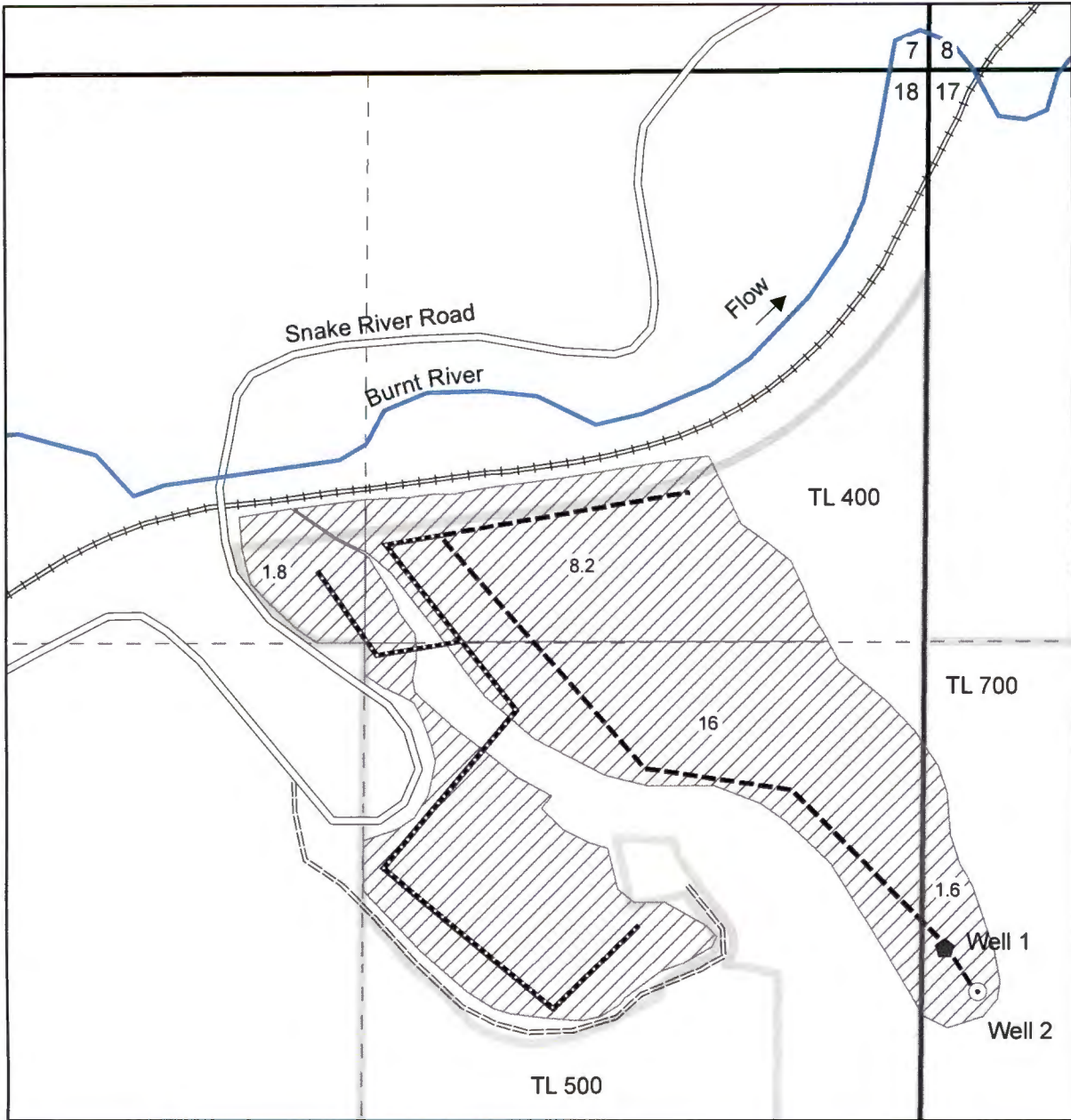


# T14S, R45E, Sections 17 and 18, Willamette Meridian



Proposed well 1 is located in the SW NW, T14S, R45E, Section 17, 55 feet east and 2040 feet south of the northwest corner of Section 17.

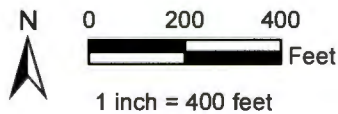
Proposed well 2 is located in the SW NW, T14S, R45E, Section 17, 130 feet east and 2145 feet south of the northwest corner of Section 17.
