PUBLIC INTEREST PRESUMPTION; GROUNDWATER

B3. **Groundwater availability remarks:** There are no OWRD Observation Well data in the area of the proposed POA so groundwater over-appropriation cannot be determined. There are also no permitted groundwater POAs within several miles of the proposed POA so injury to existing permitted groundwater users is unlikely.

Comments: Interference @ 30 d could not be estimated because the terrain (high-relief slopes) and geology (fractured bedrock aquifer) do not meet model assumptions of the widely accepted techniques for determining stream depletion (e.g., Hunt 1999, 2003).
