PUBLIC INTEREST PRESUMPTION; GROUNDWATER

OAR 690-310-130 (1) *The Department shall presume that a proposed groundwater use will ensure the preservation of the public welfare, safety and health as described in ORS 537.525.* Department staff review groundwater applications under OAR 690-310-140 to determine whether the presumption is established. A4. **Comments:** The proposed POA well location is near the City of Portland's municipal well field next to the Columbia River, and proposes to produce from unconfined alluvium, likely Troutdale Formation gravels. The applicant states that the well is be used as a backup supply, in case the municipal supply is contaminated. The maximum rate requested is 1.56 cfs, however the total acre-feet per year on the application is 461 AF, averaging 0.636 cfs. The impacts of pumping at the proposed POA location shall be evaluated at the higher rate, however, in case the rate of 1.56 cfs is sustained for extended periods of time.

B3. **Groundwater availability remarks:** The proposed point of appropriation is likely to have a high degree of hydraulic connection to the Columbia River and Columbia Slough. Nearby observation well MULT 52396, located 6200 feet ENE of the proposed POA location, shows stable water levels for the entire record since 1970 (see attached hydrograph).

Basis for aquifer confinement evaluation: Deposits of fine-grained silts or clays are likely above the water-bearing zone, any local confinement provided is truncated by the incision of the Columbia River (USGS, 1993). There is little evidence of confining pressure reported in local well logs, with little or no change in static levels at various depths.

C6. **SW / GW Remarks and Conditions:** An evaluation of potential stream depletion was composed using the model of Hunt (1999), using the most likely aquifer parameters for the gravel-dominated portion of the Troutdale Formation (see attached). The results of this model run show that the percentage of pumped water coming from the Columbia Slough at 30 days is much less than 25%. The applicant stated that this well is to be used in emergency situations, if the municipal supply is interrupted or contaminated. I do not expect significant impacts to nearby surface waters from pumping at the proposed location and aquifer.

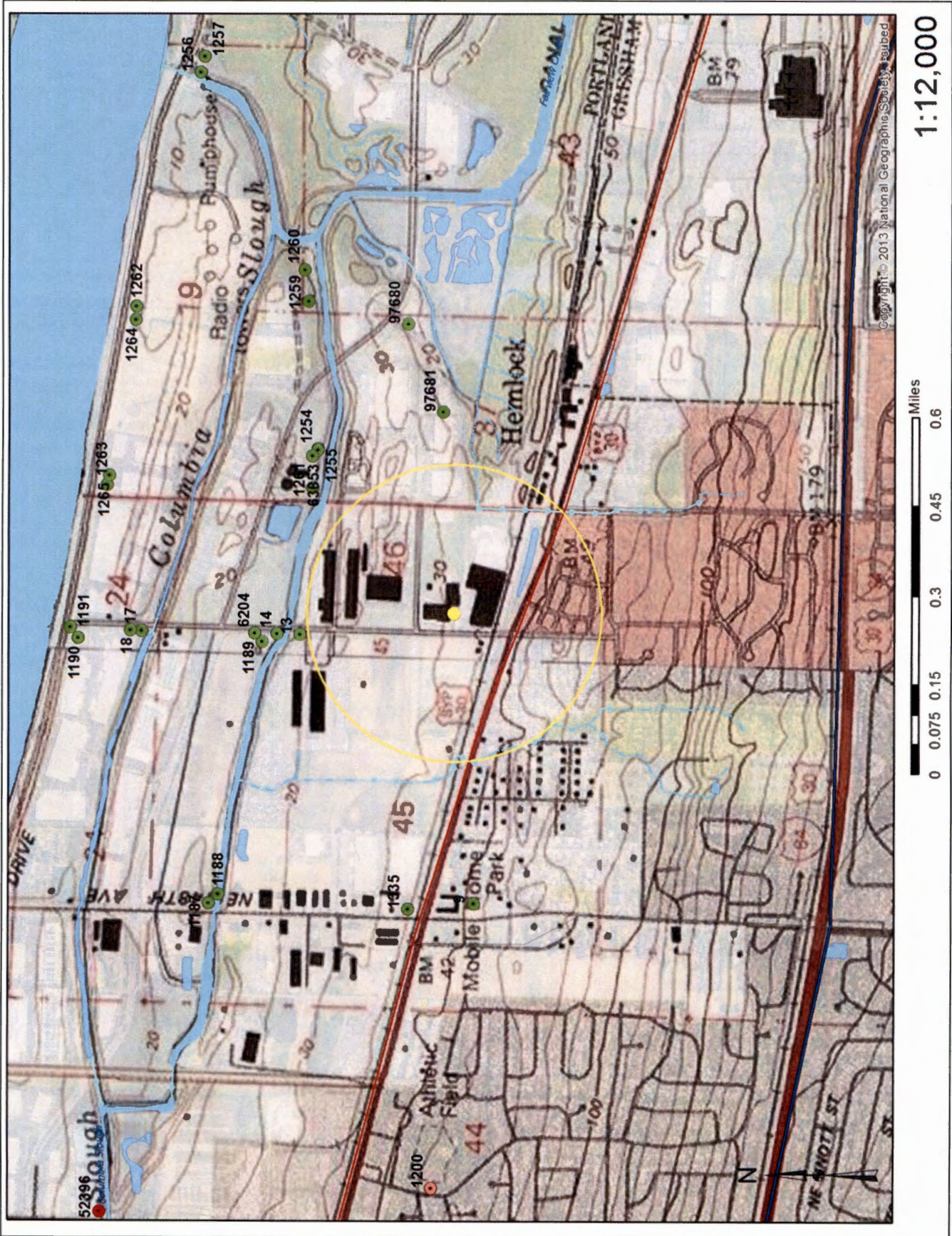


Figure 1: Proposed POA location (yellow dot) and its proximity to nearby wells (green dots) and surface waters. The yellow circle indicates one-quarter mile from the POA in all directions.

Water-Level Trends in Nearby Wells

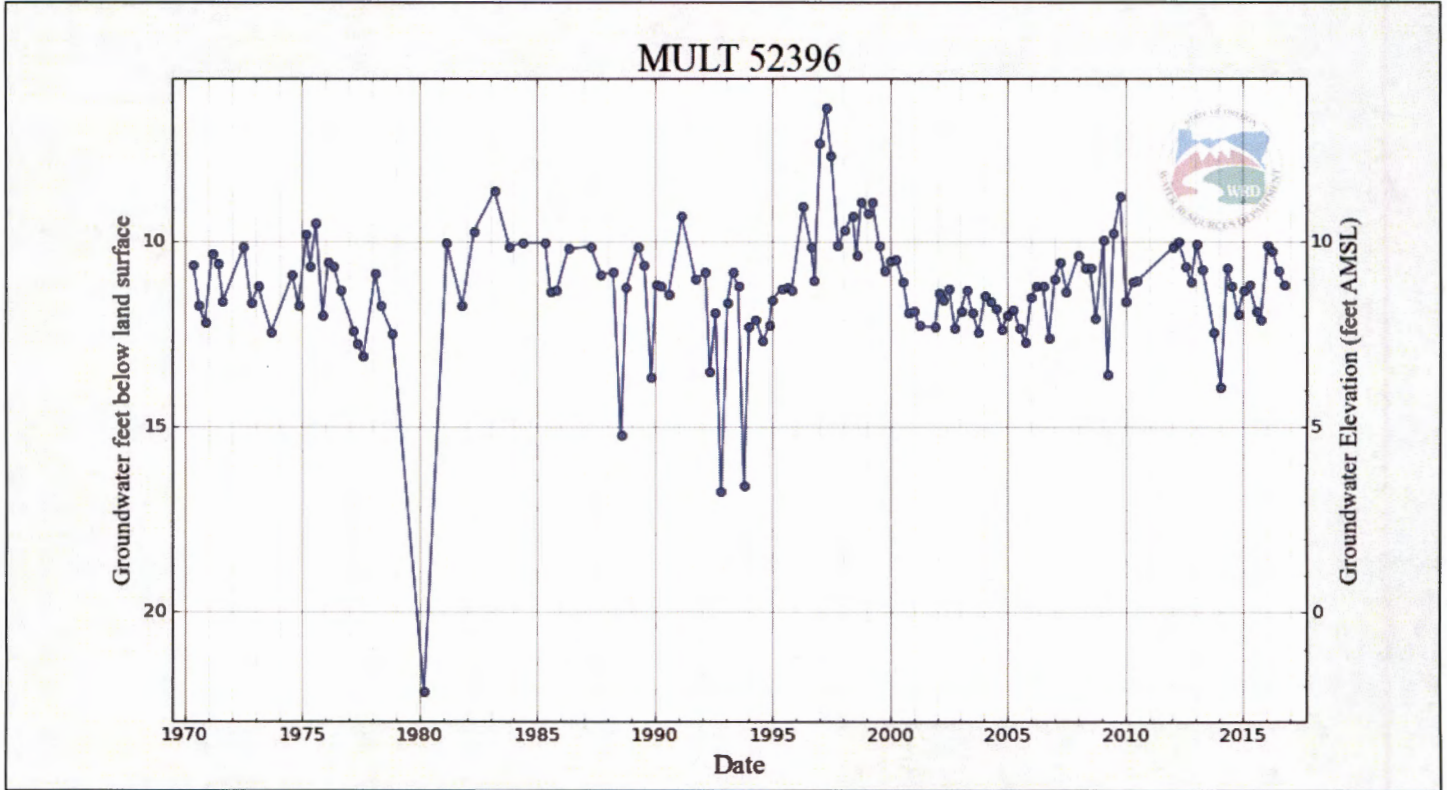


Figure 2: Hydrograph for nearby well MULT 52396, located ~6200' ENE of the proposed POA location.

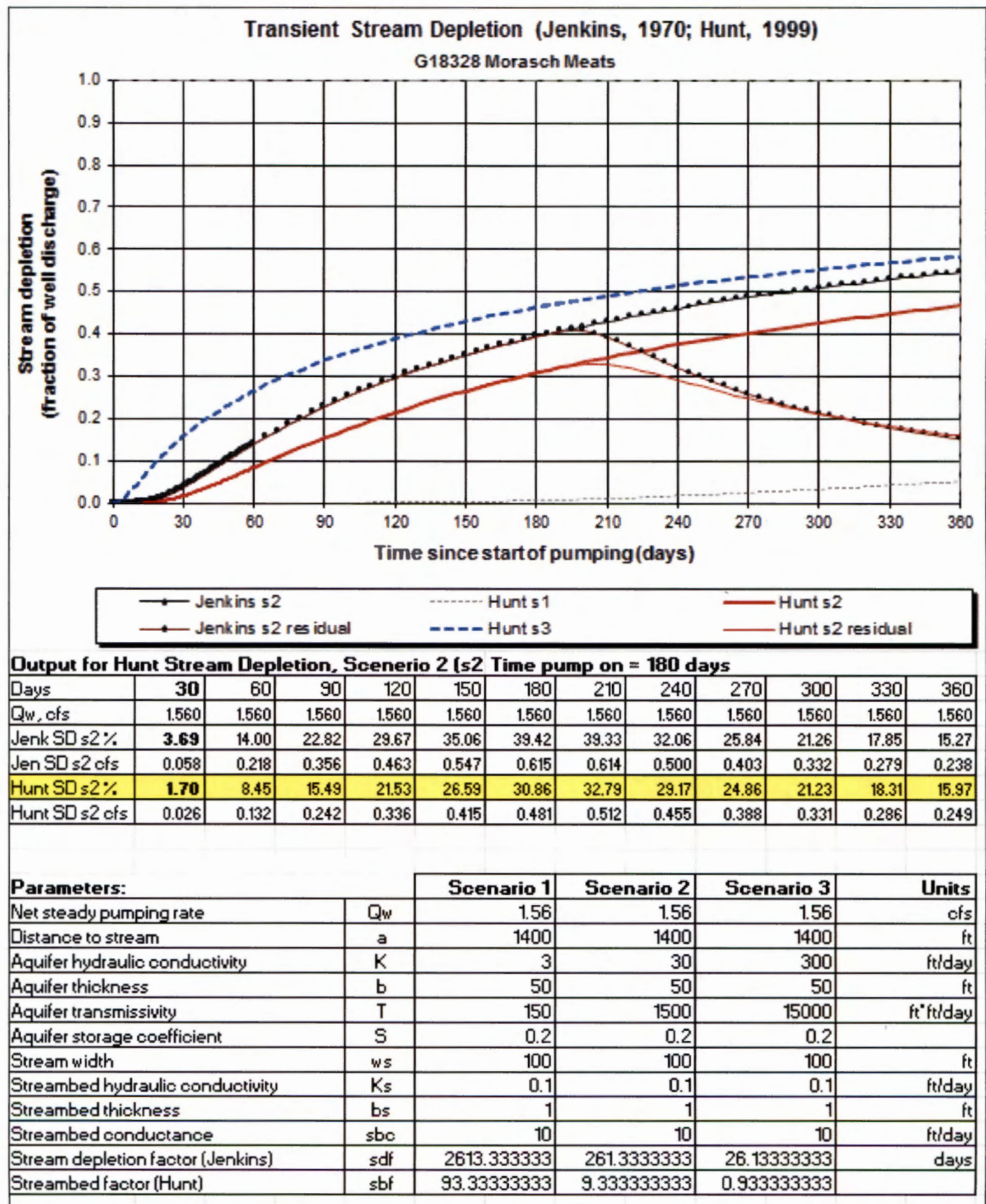


Figure 3: Expected stream depletion using the model of Hunt (1999) and the most likely aquifer parameters (scenario 2; red lines).
