Please read this Proposed Final Order in its entirety.

In summary, the Department proposes to:

 Grant an extension of time to apply water to full beneficial use from October 1, 2014, to October 1, 2019.¹

This Extension of Time request is being processed in accordance with Oregon Revised Statute 537.230 and 539.010(5), and Oregon Administrative Rule Chapter 690, Division 315

¹ Pursuant to ORS 537.230(4), upon the completion of beneficial use of water allowed under the permit, the permit holder shall hire a certified water rights examiner to survey the appropriation. Within one year after the complete application of water to a beneficial use (or by the date allowed for the complete application of water to a beneficial use), the permit holder shall submit a map of the survey and the claim of beneficial use.

AUTHORITY

Generally, see ORS 537.230 and OAR Chapter 690 Division 315.

ORS 537.230(3) provides in pertinent part that the Oregon Water Resources Department (Department) may, for good cause shown, order an extension of time within which irrigation or other works shall be completed or the right perfected. In determining the extension, the Department shall give due weight to the considerations described under ORS 539.010(5) and to whether other governmental requirements relating to the project have significantly delayed completion of construction or perfection of the right.

ORS 539.010(5) instructs the Director to consider: the cost of the appropriation and application of the water to a beneficial purpose; the good faith of the appropriator; the market for water or power to be supplied; the present demands therefor; and the income or use that may be required to provide fair and reasonable returns upon the investment.

OAR 690-315-0040 provides that in order to approve an application for an extension of time to complete construction or apply water to full beneficial use, the Department shall make the findings in OAR 690-315-0040(1) including a finding that there is "good cause" to approve the extension. OAR 690-315-0040(2)-(4) contains the factors that the Department must consider to make findings that support a "good cause" determination.

FINDINGS OF FACT

- 1. On July 31, 2006, Permit R-14279 was issued by the Department. The permit authorizes the storage of up to 23.0 AF of water in Freeman and Sons 2 from the runoff and a spring, tributaries of McMahan Branch, for multiple purpose. The permit specified the reservoir shall be filled and complete application of the stored water to the use shall be made on or before October 1, 2010.
- 2. One prior permit extension has been granted for R-14279. The most recent extension request resulted in the completion date for full application of water being extended from October 1, 2010 to October 1, 2014.

- On January 12, 2017, on behalf of the permit holder, Gerald C. Freeman, authorized representative of Freeman and Sons, submitted an "Application for Extension of Time" (Application) to the Department, requesting the time to apply water to full beneficial use under the terms and conditions of Permit R-14279 be extended from October 1, 2014, to October 1, 2019.
- 4. On January 17, 2017, notification of the Application for Permit R-14279 was published in the Department's Public Notice. No public comments were received.
- On February 13, 2017, the permit holder submitted additional information to supplement their Application. The additional information included the required Progress Report that was due October 1, 2014.

Review Criteria [OAR 690-315-0040]

In order to approve an Application for an Extension of Time to complete construction and/or apply water to full beneficial use pursuant to ORS 537.230 or 537.630, or to begin construction, pursuant to ORS 537.248, the Department must make the findings in OAR 690-315-0040(1)(a) – (d).

Complete Extension of Time Application [OAR 690-315-0040(1)(a)]

6. On January 12, 2017, the Department received a completed Application and the fee specified in ORS 536.050 from the permit holder.

Start of Construction [OAR 690-315-0040(1)(b) and 690-315-0040(5)]

- 7. Construction of Freeman and Sons 2 (Reservoir) began prior to October 1, 2010, as specified in the permit as being the date to apply water to full beneficial use. The permit holder states, construction of the Reservoir began July 5, 2010, with the excavation of the reservoir area.
- 8. According to the Application for Extension of Time submitted to the Department September 28, 2010, construction of the Reservoir began May 2010, with the following work being accomplished:
 - Scraping the floor and building the dam; and
 - Installation of 6 inch pipe.

Based on Finding of Fact (FOF) 7 and 8, the Department has determined the permit holder has satisfied the condition requiring beginning of construction of the water works.

Good Cause [OAR 690-315-0040(1)(d)]

The Department must find that there is "good cause" to approve the extension. In making a "good cause" finding, the Department shall consider the requirements set forth under OAR 690-315-0040(2).

Reasonable Diligence of the Appropriator [OAR 690-315-0040(2)(a)]

In order to make a finding of "good cause" to approve the extension, the Department shall consider whether the applicant has demonstrated "reasonable diligence" in previous performance under the permit. OAR 690-315-0040(2)(a). In determining "reasonable diligence", the Department shall consider, but is not limited to, the following factors: a) The amount of construction completed within the time allowed in the permit or previous extension; b) The amount of beneficial use made of the water during the permit or previous extension time limits; c) Water right holder conformance with the permit or previous extension conditions; and d) Financial investments made toward developing the beneficial use of water.

Amount of Construction [OAR 690-315-0040(3)(a)]

The amount of construction completed within the time allowed in the previous extension.²

- 9. During the most recent extension period, being from October 1, 2010, to October 1, 2014, the following was accomplished:
 - Continued excavation and dam emplacement;
 - Installed an 8 inch outlet gate; and
 - · Completed construction of the dam.
- 10. No other work has been accomplished since October 1, 2014.

Based on FOF 9, the Department has determined that work has been accomplished within the time allowed in the previous extension, which provides evidence of good cause and reasonable diligence from the appropriator towards the complete application of water to a beneficial use.

Compliance with Conditions [OAR 690-315-0040(3)(c)]

The water right permit holder's conformance with the previous extension conditions.

- 11. In 2011, the permit holder installed an 8 inch outlet gate.
- On January 12, 2017, the permit holder submitted documentation, dated December 16, 2016, from ODFW waiving the condition to install fish screening and bypass devices, as they are not required for Permit R-14279. This letter is in the file for Permit R-14279.
- On February 13, 2017, the permit holder submitted the Progress Report that was due October 1, 2014, as required by the previous extension of time Final Order that was issued August 19, 2011.

² "Actual Construction" is defined in OAR 690-315-0020(3)(d)(A)and(B) as physical work performed toward completion of the water system which demonstrates the water right permit holder's good faith and intention to complete the project with reasonable diligence. Actual construction does not include planning a diversion system, formulating a business plan, securing financing, letting contracts, purchasing but not installing equipment, surveying, clearing land or planting crops.

The Department has determined based on FOF 11, 12, and 13 that the permit holder has demonstrated compliance with the following permit and extension conditions, as required by Permit R-14279:

- "The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or the provision of other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights";
- "The permittee shall install, maintain, and operate fish screening and by-pass
 devices consistent with current Oregon Department of Fish and Wildlife (ODFW)
 standards.....The required screen and by-pass devices are to be in place and
 functional, and approved in writing by ODFW prior to diversion of any water. The
 permittee may submit evidence in writing that ODFW has determined screens
 and/or by-pass devices are not necessary"; and
- "The permit holder must submit a completed Progress Report Form to the Department by October 1, 2014."
- 14. The Department has considered the permit holder's compliance with conditions, and has identified the following concern: the record does not show that a meter or other suitable measuring device has been installed.

The Department has determined based on FOF 14, that the permit holder has not demonstrated compliance with following permit conditions as required by Permit R-14279:

 "Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director."

In order to legally perfect the use of water under this permit, the permit holder must demonstrate that all conditions of the permit have been satisfied.

Beneficial Use of Water [OAR 690-315-0040(3)(b)]

The amount of beneficial use made of the water during the previous extension time limits.

- 15. The Application states a maximum volume of 23.0 AF of water has been diverted from runoff and a spring, tributaries of McMahan Branch, for multiple purpose.
- 16. According to the permit holder delay of full beneficial use of water under Permit R-14279 was due, in part, the permit holder never used the stored water for irrigation as originally planned, and the permit holder didn't understand that a measuring device would still be required. The permit holder has since received approval from the District Watermaster to install a staff gage. The permit holder needs more time in which to

access the pool area to install the staff gage, as the reservoir remains full during the authorized storage season, and needs to be dry enough to make the bottom surface safe to access for installation of the staff gage.

Based on FOF 14, the Department has determined that beneficial use of water has not yet been demonstrated under this permit because not all permit conditions were satisfied by October 1, 2014.

Financial Investments to appropriate and Apply Water to a Beneficial Purpose [OAR 690-315-0040(2)(b),(3)(d),(4)(d)]

17. The Application states the permit holder has invested approximately \$43,617, which is about 99 percent of the total projected cost for complete development of this project. The permit holder anticipates an additional \$300 investment is needed for the completion of this project.

The Department has determined based on FOF 17, that the permit holder had made an investment, which provides evidence of good cause and reasonable diligence towards the complete application of water to a beneficial use.

Reasonable Diligence of the Appropriator [OAR 690-315-0040(2)(a)]

The Application provides evidence of progress towards completion of the water system; a financial investment has been made; the permit holder has not demonstrated compliance with all permit conditions, and; beneficial use has not been demonstrated. The Department has determined the applicant has demonstrated the minimum necessary for the Department to find reasonable diligence towards complete application of water to a beneficial use.

The Market and Present Demands for Water [OAR 690-315-0040(4)(a-f)]

The Department's determinations of market and present demand for water or power to be supplied shall consider the requirements set forth under OAR 690-315-0040(4)(a-f). In accordance with OAR 690-315-0040(4), the Department shall consider, but is not limited to, the following factors when determining the market and the present demand for water or power to be supplied:

- (a)The amount of water available to satisfy other affected water rights and scenic waterway flows;
- (b) Special water use designations established since permit issuance, including but not limited to state scenic waterways, federal wild and scenic rivers, serious water management problem areas or water quality limited sources established under 33 U.S.C. 1313(d);
- (c) The habitat needs of sensitive, threatened or endangered species, in consultation with the Oregon Department of Fish and Wildlife;
- (d) Economic investment in the project to date;
- (e) Other economic interests dependent on completion of the project; and

 (f) Other factors relevant to the determination of the market and present demands for water and power.

OAR 690-315-0040(4)(a)

The amount of water available to satisfy other affected water rights and scenic waterway flows.

- 18. A review of the amount of water available to satisfy other affected water rights and scenic waterway flows was determined at the time of issuance of Permit R-14279; furthermore, water availability for other affected water rights and scenic waterway flows after the permit was issued is determined when an application for a new water right is submitted.
- 19. Current Water Availability Analysis for Rickreall Creek, Tributary of Willamette River at the mouth (watershed ID 30200702) shows that no water is available during the months of August and September at the 50% exceedance level.

OAR 690-315-0040(4)(b)

Special water use designations established since permit issuance, including but not limited to state scenic waterways, federal wild and scenic rivers, serious water management problem areas or water quality limited sources established under 33 U.S.C. 1313(d).

- 20. The points of diversion are located on tributaries of Rickreall Creek, and are not located within a Withdrawn Area.
- 21. Rickreall Creek is not located within or above a state or federal scenic waterway.
- 22. The points of diversion are not in a location listed by the Department of Environmental Quality as a water quality limited stream.

OAR 690-315-0040(4)(c)

The habitat needs of sensitive, threatened or endangered species, in consultation with the Oregon Department of Fish and Wildlife.

23. Rickreall Creek is located within an area ranked "high" for stream flow restoration needs as determined by the Department in consultation with the Oregon Department of Fish and Wildlife, and is located within a Sensitive, Threatened or Endangered Fish Species Area as identified by the Department in consultation with Oregon Department of Fish and Wildlife.

OAR 690-315-0040(4)(d)

Economic interests dependent on completion of the project.

24. The Application states an approximate total of \$43,617 has been invested in the project.

OAR 690-315-0040(4)(e)

Other economic interests dependent on completion of the project.

25. The Application did not identify economic interests other than those of the applicant's that may be dependent on completion of the project.

OAR 690-315-0040(4)(f)

Other factors relevant to the determination of the market and present demand for water and power.

26. No other factors relevant to the determination of the market and present demand for water and power have been identified.

OAR 690-315-0040(2)(f)

Fair Return Upon Investment

27. The Application states the storage of the water in the Reservoir benefits the wildlife, and adds an aesthetic value to the property.

OAR 690-315-0040(2)(g) Other Governmental Requirements

28. The Application did not identify any delay in the development of this project that was caused by any other governmental requirements.

Unforeseen Events [OAR 690-315-0040(2)(h)]

29. The Application did not identify any unforeseen events.

Denial of an Extension Would Result in Undue Hardship [OAR 690-315-0040(2)(i)]

30. The Application did state if a denial of the extension would result in undue hardship. A denial of the extension would cost the permit holder more time and money that has already been invested, as the permit for storage of water could be lost, and the structure which is already complete would need to be breached, or a new application for storage of water would have to be submitted.

Good Faith of the Appropriator [OAR 690-315-0040(2)(c)]

31. The Department has found good faith of the appropriator under Permit R-14279.

Based on FOF 7, 8, 9, 11, 12, 13, 15, 17, and 24, the Department has determined that the applicant has shown good faith and reasonable diligence.

Duration of Extension [OAR 690-315-0040(1)(c)]

Under OAR 690-315-0040(1)(c), in order to approve an extension of time for water use permits the Department must find that the time requested is reasonable and the applicant can complete the project within the time requested.

32. As of January 12, 2017, the permit holder states the remaining work to be completed consists of meeting all permit conditions, including installing a meter or other suitable measuring device, and applying water to full beneficial use.

Given the amount of development left to occur, the Department has determined that the permit holder's request to have until October 1, 2019, to accomplish the application of water to beneficial use under the terms and conditions of Permit R-14279 is both reasonable and necessary.

Good Cause [OAR 690-315-0040(1)(d)]

The Department must find that there is "good cause" to approve the extension. In making a "good cause" finding, the Department shall consider the requirements set forth under OAR 690-315-0040(2).

The Department has considered the reasonable diligence and good faith of the appropriator, the cost to appropriate and apply water to a beneficial purpose, the market and present demands for water to be supplied, the financial investment made and fair and reasonable return upon the investment, the requirements of other governmental agencies, and unforeseen events over which the permit holder had no control, whether denial of the extension will result in undue hardship to the applicant and whether there are no other reasonable alternatives for meeting water use needs, any other factors relevant to a determination of good cause, and has determined that the applicant has shown that good cause exists for an extension of time to apply water to full beneficial use pursuant to OAR 690-315-0040(1)(d).

CONCLUSIONS OF LAW

- 1. The Applicant has submitted a complete extension application form and the fee specified in ORS 536.050, as required by OAR 690-315-0040(1)(a).
- 2. The Applicant complied with construction timeline requirements to begin construction as required by ORS 537.230, OAR 690-315-0040(1)(b) and OAR 690-315-0040(5).
- 3. Based on Finding of Facts 7 through 31, full application of water to beneficial use can be accomplished by October 1, 2019³, as required by OAR 690-315-0040(1)(c).

Proposed Final Order: Permit R-14279

³Pursuant to ORS 537.230(3), upon the completion of beneficial use of water allowed under the permit, the permittee shall hire a certified water rights examiner to survey the appropriation. Within one year after the complete application of water to a beneficial use (or by the date allowed for the complete application of water to a beneficial use), the permittee shall submit a map of the survey and a new or revised claim of beneficial use as deemed appropriate by the Department.

- 4. The Applicant can complete the project within the time period requested for the extension on the project. OAR 690-315-0050(5).
- 5. The Applicant has demonstrated good cause for the extension. OAR 690-315-0050(5).

PROPOSED ORDER

Based upon the foregoing Findings of Fact and Conclusions of Law, the Department proposes to issue an order to:

Extend the time to apply water to beneficial use under Permit R-14279 from October 1, 2014, to October 1, 2019.

Proposed Final Order Hearing Rights

- 1. Under the provisions of OAR 690-315-0100(1) and 690-315-0060, the applicant or any other person adversely affected or aggrieved by the proposed final order may submit a written protest to the proposed final order. The written protest must be received by the Water Resources Department no later than <u>April 14, 2017</u>, being 45 days from the date of publication of the proposed final order in the Department's weekly notice.
- 2. A written protest shall include:
 - a. The name, address and telephone number of the petitioner;
 - A description of the petitioner's interest in the proposed final order and if the protestant claims to represent the public interest, a precise statement of the public interest represented;
 - c. A detailed description of how the action proposed in the proposed final order would adversely affect or aggrieve the petitioner's interest;
 - d. A detailed description of how the proposed final order is in error or deficient and how to correct the alleged error or deficiency;
 - e. Any citation of legal authority supporting the petitioner, if known;

- f. Proof of service of the protest upon the water right permit holder, if petitioner is other than the water right permit holder; and
- g. The applicant or non-applicant protest fee required under ORS 536.050.
- 3. Within 60 days after the close of the period for requesting a contested case hearing, the Director shall:
 - a. Issue a final order on the extension request; or
 - b. Schedule a contested case hearing if a protest has been submitted, and:
 - 1) Upon review of the issues, the Director finds there are significant disputes related to the proposed agency action; or
 - 2) The applicant submits a written request for a contested case hearing within 30 days after the close of the period for submitting protests.
