PREPONDERANCE OF EVIDENCE FINDING UNDER ORS 390.835:

Department has found that there is a preponderance of evidence that the proposed use of ground water will measurably reduce the surface water flows necessary to maintain the free-flowing character of the Deschutes Scenic Waterway in quantities necessary for recreation, fish and wildlife.

LOCALIZED IMPACT FINDING

The proposed use of ground water will have a localized impact to surface water in the _____ River/Creek Subbasin.

If the localized impact box above is checked, then the water use under any right issued pursuant to this application is presumed to have a localized impact on surface water within the identified subbasin. Mitigation of the impact, originating from within the Local Zone of Impact identified by the Department, will be required before a permit may be issued for the proposed use.

The well is within the USGS Groundwater Study Area and subject to Division 690-505-0500 to 0620.

B3. **Groundwater availability remarks:** _____

The nearest state observation well is JEFF 325, located approximately 0.6 miles to the northwest of the well. JEFF 325 has been monitored periodically since the mid 1990's through present. Overall, the water level in JEFF 325 has risen about 5 feet during the period of record. The hydrograph for JEFF 325 shows fluctuations which are likely driven by climatic factors, although long-term effects from the filling of Lake Billy Chinook / Lake Simtustus / Pelton Regulating Reservoir may be driving the overall increase in water level.

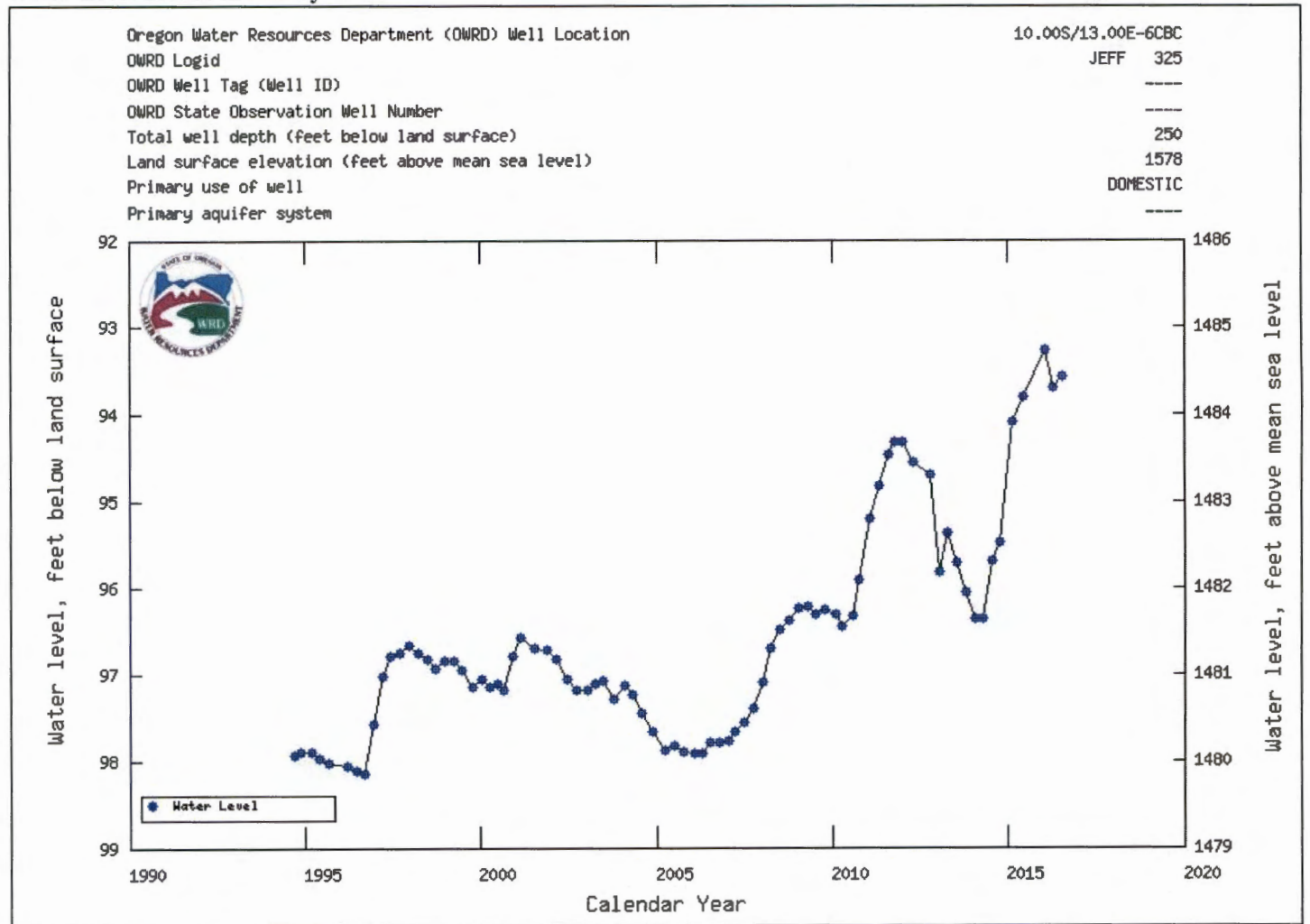

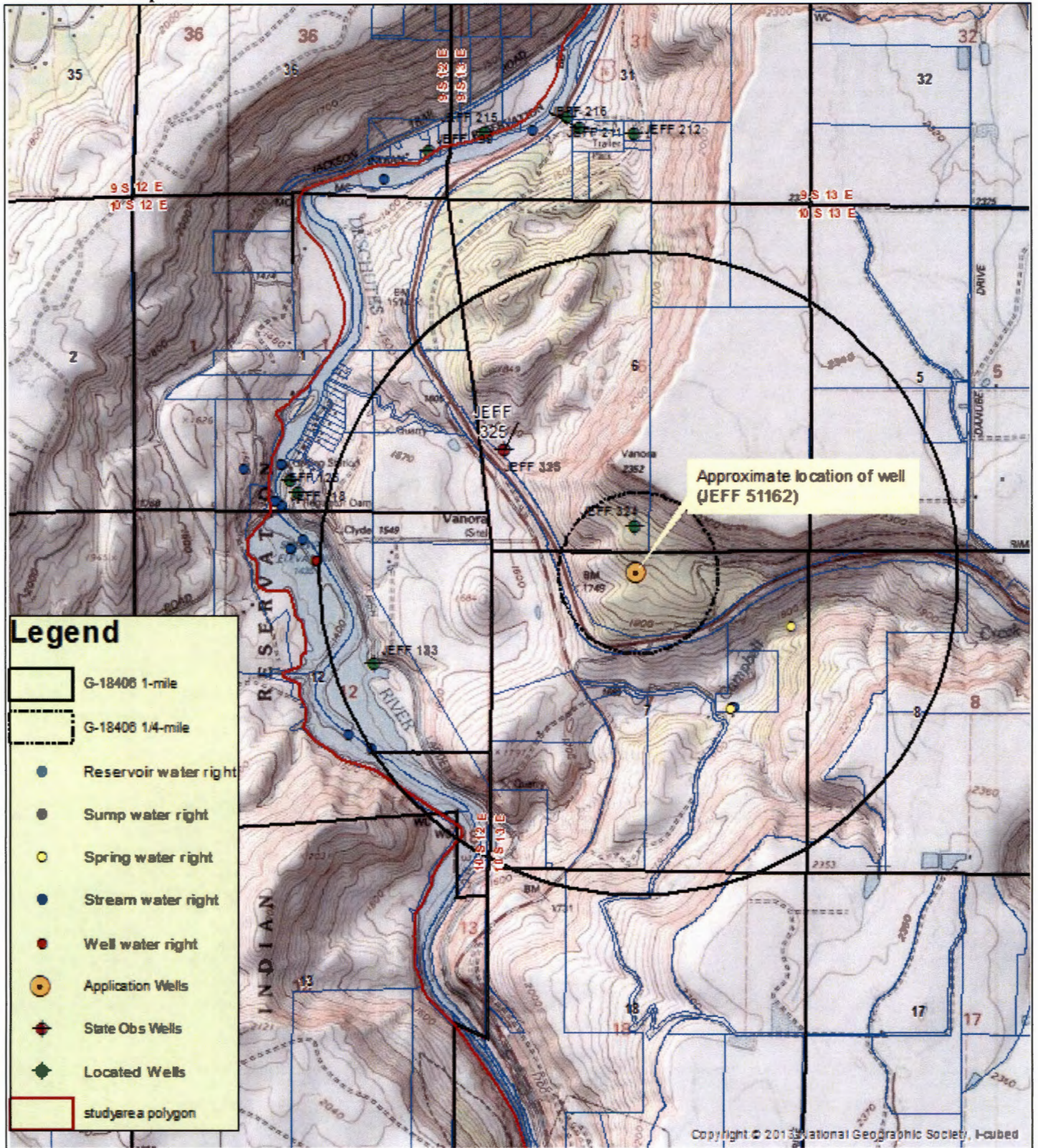
