In response to your letter of October 14, 1994, the Umpqua National Forest would like to amend its Application for a Permit to Appropriate Ground Water (Application G-11103) at the two well sites. It is necessary to amend the application to clarify the proper locations of the water use. This is neither an increase in the amount of water use nor a change in the type of water use.

Please make these changes to the following items (these are the item numbers as they appear on the original application):

Item 3. Add the following locations to describe the full extent of the water use at the Diamond Lake and Broken Arrow campgrounds, the South Shore picnic area, and the North End boat ramp. These locations were not accurately shown on the application map, but are described in the Description of Works in the original application.
