FINAL ORDER
APPROVING THE USE OF
STORED WATER

Authority

ORS 537.147 establishes the process by which an application to use stored water exclusively may be submitted. OAR Chapter 690, Divisions 310 and 340 implement the statute, and provide the Department's procedures and criteria for evaluating applications to use stored water exclusively.

Findings of Fact

1. On March 23, 2016, JEFF PHILLIPS submitted an application for a water-use permit pursuant to ORS 537.147.
2. The Department provided public notice of the application in the Department's weekly public notice on July 26, 2016. A 30-day comment period followed.
3. The Department has evaluated the application and any comments received, and finds that no public interest in ORS 537.170(8) would be affected adversely by the proposed use.
4. The Department finds that the 0.10 acre-foot (AF) of water available under R-15178 is insufficient for both the primary irrigation and supplemental irrigation requested.


Conclusions of Law

1. The 0.10 AF available under R-15178 may be applied as supplemental irrigation on the place-of-use for the existing right (Certificate 10217).
2. Application S-88256 is consistent with the requirements of ORS 537.147, and OAR Chapter 690.

Now Therefore, it is Ordered:

Application S-88256 is approved, and Permit S-55056 is issued as limited by the conditions contained therein.
