The proposed reservoir is to be located on an unnamed, intermittent stream that is tributary to the South Yamhill River. The source of water for the reservoir will be runoff impounded behind the reservoir berm.

The anticipated design for the reservoir includes the following elements:

- An earthen berm constructed on the downstream side of the reservoir footprint, across the existing natural drainage way (refer to the enclosed application map).
- The berm will be a maximum height of approximately 9.9 feet above natural grade.
- The length of the berm will be approximately 120 feet.
- The interior of the reservoir will be excavated up to 5 feet below the existing land surface.
- An outlet pipe will be installed through the berm to allow draining of the reservoir when needed.
- Based on discussions with ODFW, fish passage will not be needed.

A generalized cross section through the longitudinal axis of the reservoir is provide in Attachment C. NOTE: This cross-section is intended as a conceptual drawing for the purpose of applying for a water right but is not intended to be an engineering design of the reservoir for the purposes of construction.

A person owning or operating an AO shall, prior to construction, fundamental change in permit status or abandonment of the AO in any waters of this state, obtain a determination from ODFW as to whether NMF are or historically have been present in the waters. If ODFW determines that NMF are or historically have been present in the waters, the person owning or operating the AO shall either submit a proposal for fish passage to ODFW or apply for a waiver or exemption. Approval of the proposed fish-passage facility, waiver, or exemption must be obtained from the department prior to construction, permit modification or abandonment of the AO. Approved fish-passage plans, waivers, and exemptions shall maintain adequate passage of NMF at all times (ORS 509.601) as per the approved plan, waiver or exemption.


