Dear Oregon Department of Fish and Wildlife:

THIS IS THE INITIAL REVIEW AND <u>IS SUBJECT TO CHANGE</u> AT THE NEXT PHASE OF PROCESSING

This letter is to inform you of the preliminary analysis of the water right application. This document, called an "Initial Review", is to inform you of the potential limitations to the proposed instream water rights and to describe some options. Based on the information you provided, the Oregon Water Resources Department (OWRD) has made the following initial determinations:

Initial Determinations:

- 1. The referenced applications are complete and not defective.
- 2. The proposed use is not prohibited, restricted or limited by law.
- 3. Water is available from the proposed source during the times and in the amounts requested.
- 4. The reaches proposed in this application for instream water rights are in the Hood Basin.
- 5. Per the Hood Basin Program (OAR 690-504-0000(1)), fish life and wildlife are classified as Public Uses as defined in ORS 537.332(5)(b) and OAR 690-077-0010(27)(b).
- 6. All amounts of water are in cubic feet per second.
- 7. For these applications the estimated monthly average natural flow exceeds the amount that the applicant requested.

Summary of determination:

The water applied for has been determined allocable in the amounts requested for the purpose identified in each application.
