Dear Mr. Wallin:

The Coquille Indian Tribe (the Tribe) is submitting an application for a permit to store water in a reservoir on their "Seven Devils" property. The Tribe is currently the holder of Permit R-12619, which authorizes the storage of up to 30 acre feet of water from Threemile Creek and an unnamed tributary and Fivemile Creek and an unnamed tributary. This application requests a permit that will replace Permit R-12619, which will be cancelled upon approval of this application. Seven Devils Reservoir 3 will store a maximum of 5 acre feet of precipitation and run-off for multipurpose storage, including storage for cranberry use, temperature control, pest control, and harvesting for cranberries.

Please find enclosed an application for a permit to store water, which requests processing under the "alternate reservoir" process. Also enclosed is the required fee of \$950.00, which was calculated as follows:





ODFW visited the site with Coquille Tribal Environmental staff (Helena Linnell) on 06/23/17. This small reservoir with capacity to store ~5.0 acre/ft has been constructed primarily through excavation into a gentle sloping flat ~1/4 mile upslope from Fivemile Creek, direct tributary to the Pacific Ocean. The current use is for cranberry farming and water is stored from surface runoff into the reservoir until the time at which it is pumped to existing cranberry bogs. There were no streams observed entering the reservoir. Fish are not believed to be present in the reservoir as there is not a channel connecting the reservoir to Fivemile Creek, which is the closest fish bearing stream. A fishway is not needed for this reservoir and there is not a need to require screening to protect native fish. It is recommended, but not required, that a screen that has sufficiently small mesh size (1/4 inch) be operated when pumping at this site to prevent entrainment of amphibians into the pump intake. The shoreline soils of this reservoir have largely healed since construction and provide fair habitat for amphibians, ducks, and songbirds.

A person owning or operating an AO shall, prior to construction, fundamental change in permit status or abandonment of the AO in any waters of this state, obtain a determination from ODFW as to whether NMF are or historically have been present in the waters. Permittee shall obtain written approval from ODFW that the installation of the required screen and by-pass devices meets the state's criteria or the permittee shall submit documentation that ODFW has determined screens and/or by-pass devices are not necessary.

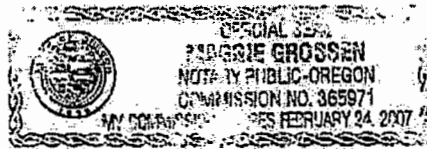

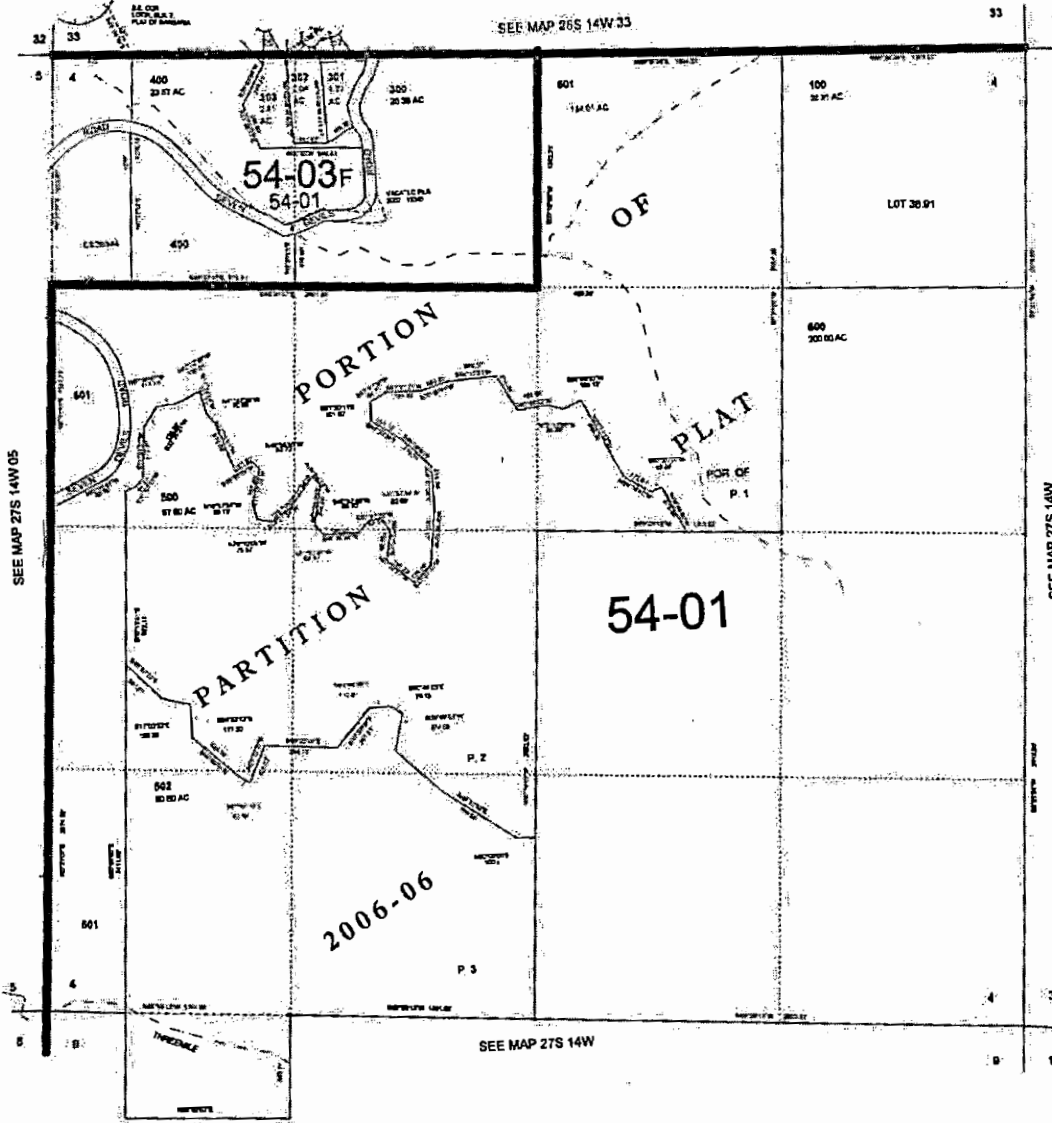
