Re: Application for a Permit to Store Water - Coquille Indian Tribe

Dear Mr. Wallin:

The Coquille Indian Tribe (the Tribe) is submitting an application for a permit to store water in a reservoir on their "Seven Devils" property. The Tribe is currently the holder of Permit R-12619, which authorizes the storage of up to 30 acre feet of water from Threemile Creek and an unnamed tributary and Fivemile Creek and an unnamed tributary. This application requests a permit that will replace Permit R-12619, which will be cancelled upon approval of this application. Seven Devils Reservoir 3 will store a maximum of 5 acre feet of precipitation and run-off for multipurpose storage, including storage for cranberry use, temperature control, pest control, and harvesting for cranberries.

Please find enclosed an application for a permit to store water, which requests processing under the "alternate reservoir" process. Also enclosed is the required fee of \$950.00, which was calculated as follows:

ODFW visited the site with Coquille Tribal Environmental staff (Helena Linnell) on 06/23/17. This small reservoir with capacity to store ~5.0 acre/ft has been constructed primarily through excavation into a gentle sloping flat ~1/4 mile upslope from Fivemile Creek, direct tributary to the Pacific Ocean. The current use is for cranberry farming and water is stored from surface runoff into the reservoir until the time at which it is pumped to existing cranberry bogs. There were no streams observed entering the reservoir. Fish are not believed to be present in the reservoir as there is not a channel connecting the reservoir to Fivemile Creek, which is the closest fish bearing stream. A fishway is <u>not</u> needed for this reservoir and there is <u>not</u> a need to require screening to protect native fish. It is recommended, but not required, that a screen that has sufficiently small mesh size (1/4 inch) be operated when pumping at this site to prevent entrainment of amphibians into the pump intake. The shoreline soils of this reservoir have largely healed since construction and provide fair habitat for amphibians, ducks, and songhirds.

fishpass: As required by ORS 509.585, a person owning or operating an artificial obstruction (AO) may not construct or maintain any AO across any waters of this state that are inhabited, or historically inhabited, by native migratory fish (NMF) without providing passage for NMF. A person owning or operating an AO shall, prior to construction, fundamental change in permit status or abandonment of the AO in any waters of this state, obtain a determination from ODFW as to whether NMF are or historically have been present in the waters. If ODFW determines that NMF are or historically have been present in the waters, the person owning or operating the AO shall either submit a proposal for fish passage to ODFW or apply for a waiver or exemption. Approval of the proposed fish-passage facility, waiver, or exemption must be obtained from the department prior to construction, permit modification or abandonment of the AO. Approved fish-passage plans, waivers, and exemptions shall maintain adequate passage of NMF at all times (ORS 509.601) as per the approved plan, waiver or exemption.

fishself: The permittee shall install, maintain, and operate fish screening and by-pass devices consistent with current Oregon Department of Fish and Wildlife (ODFW) standards. Fish screening is to prevent fish from entering the proposed diversion while by-pass devices provide adequate upstream and downstream passage for fish. The required screen and by-pass devices are to be in place and functional prior to diversion of any water. Permittee shall obtain written approval from ODFW that the installation of the required screen and by-pass devices meets the state's criteria or the permittee shall submit documentation that ODFW has determined screens and/or by-pass devices are not necessary.

fishapprove: The permittee shall install, maintain, and operate fish screening and by-pass devices consistent with current Oregon Department of Fish and Wildlife (ODFW) standards. Fish screening is to prevent fish from entering the proposed diversion while by-pass devices provide adequate upstream and downstream passage for fish. The required screen and by-pass devices are to be in place and functional, and approved in writing by ODFW prior to diversion of any water. The permittee may submit evidence in writing that ODFW has determined screens and/or by-pass devices are not necessary.

fishdiv33: If the riparian area is disturbed in the process of developing a point of diversion, the permittee shall be responsible for restoration and enhancement of such riparian area in accordance with ODFW's Fish and Wildlife Habitat Mitigation Policy OAR 635-415. For purposes of mitigation, the ODFW Fish and Wildlife Habitat Mitigation Goals and Standards, OAR 635-415, shall be followed.

The use may be restricted if the quality of the source stream or downstream waters decrease to the point that those waters no longer meet existing state or federal water quality standards due to reduced flows.

The permittee shall install, maintain, and operate fish screening and by-pass devices consistent with current Oregon Department of Fish and Wildlife (ODFW) standards. Fish screening is to prevent fish from entering the proposed diversion while by-pass devices provide adequate upstream and downstream passage for fish. The required screen and by-pass devices are to be in place and functional, and approved in writing by ODFW prior to diversion of any water. The permittee may submit evidence in writing that ODFW has determined screens and/or by-pass devices are not necessary.

fishmay: Not withstanding that ODFW has made a determination that fish screens and/or by-pass devices are not necessary at the time of permit issuance, the permittee may be required in the future to install, maintain, and operate fish screening and by-pass devices to prevent fish from entering the proposed diversion and to provide adequate upstream and downstream passage for fish.

fence: The stream and its adjacent riparian area shall be fenced to exclude livestock.

blv: Water must be diverted to a trough or tank through an enclosed water delivery system. The delivery system must be equipped with an automatic shutoff or limiting flow control mechanism or include a means for returning water to the stream source through an enclosed delivery system. The use of water shall not exceed 0.10 cubic feet per second per 1000 head of livestock.
