SURVEYOR'S CERTIFICATE

I, Bertell Mason, Jr., being first duly sworn, depose and say that I have correctly surveyed and marked with lawful monuments the lands represented on the annexed map of MOUNT HOOD GOLF CLUB TERRACE; that the initial point of said survey is a 2" diameter galvanized iron pipe, 3 feet in length, driven 6" below the surface of the ground at the northeast corner of HOOD-LAND ADDITION TO BOWMAN'S MT. HOOD GOLF CLUB, which point is described as being South 88° 14' East 1860.0 feet along the 1/2 section line from the 1/4 corner between Sections 4 and 5, T.3S, R.7E, W.M.; that the lands platted hereon are described as beginning at the aforesaid initial point and running thence South 0° 29' West 190.0 feet along the east boundary of HOOD-LAND ADDITION TO BOWMAN'S MT. HOOD GOLF CLUB to the most easterly southeast corner of said HOOD-LAND ADDITION TO BOWMAN'S MT. HOOD GOLF CLUB; thence South 88° 53' 24" East 35.32 feet to a point of curve right; thence southeasterly 140.83 feet along the arc of a curve, the long chord of which bears South 78° 48' 39" East 140.10 feet; thence South 13° 24' 15" West 86.85 feet; thence South 30° 31' 38" East 296.88 feet; thence South 48° 01' 50" East 255.32 feet; thence South 57° 46' 51" East 340.48 feet; thence South 2° 01' 30" West 149.03 feet; thence North 88° 31' 00" East 268.34 feet; thence North 1° 44' 42" West 60.16 feet; thence North 88° 30' 10" East 155.61 feet; thence North 28° 02' 10" East 104.02 feet; thence North 49° 44' 10" East 219.76 feet; thence North 28° 56' 50" East 163.65 feet; thence South 66° 08' 03" East 204.45 feet; thence North 22° 33' 05" East 537.13 feet to a point of curve left; thence northerly 211.35 feet along the arc of a curve, the long chord of which bears North 9° 06' 08" East 209.42 feet; thence North 4° 20' 49" West 256.75 feet; thence South 89° 16' 32" West 782.39 feet; thence South 47° 17' 31" West 364.23 feet; thence South 5° 33' 03" East 250.39 feet; thence South 42° 02' 05" West 260.40 feet; thence North 60° 56' 25" West 143.75 feet; thence North 78° 52' 59" West 600.1 feet; thence North 37° 07' 49" West 433.03 feet; thence North 88° 13' 09" West 252.93 feet to the point of beginning.
