Water Right Application Initial Review

Application G-18552 proposes the appropriation of 1.49 cubic feet per second (CFS) of water, being 0.93 CFS from New Well 5 (POLK 53567/L113610), New Well 12 (POLK 53561/L113608), Well 27 (POLK 2883), and Well 28 in Hayden Lake Basin for irrigation of 74.3 acres March 1 through October 31; and 0.56 CFS of water from New Well 7 (POLK 2791) for commercial uses September 1 through November 30 of each year.

Summary

The proposed groundwater use from New Well 12 (POLK 53561/L113608) will have the potential for substantial interference with Willamette River, and Well 28 will have the potential for substantial interference with Hayden Slough. Therefore, in accordance with OAR 690-400-0010(11)(a)(B), surface water availability must also be considered. Surface water from Willamette River is available during the full season requested; however surface water from Hayden Slough is not available July 1 through September 30. It is unlikely that the application will be approved for use from Well 28 unless a suitable mitigation proposal is provided prior to issuance of the Proposed Final Order and contingent upon the submittal of evidence demonstrating compliance with current minimum well construction standards for Well 28.

The appropriation of 1.49 CFS of water, being 0.93 CFS from New Well 5 (POLK 53567/L113610), Well 12 (POLK 53561/L113608), and Well 27 (POLK 2883) in Hayden Lake Basin for irrigation of 74.3 acres March 1 through October 31; and 0.56 CFS of water from New Well 7 (POLK 2791) for commercial uses September 1 through November 30 is allowable, contingent upon the submittal of evidence demonstrating compliance with current minimum well construction standards for Well 27 (POLK 2883).

Because of the favorable determinations described herein, Application G-18552 can move to the next phase of the water-rights application review process, which includes a public interest review; however the use may be limited. This initial review does not address various public interest issues or public comments. These issues will be addressed as the Department reviews comments from the public and other agencies, and prepares a Proposed Final Order. If significant public interest issues are identified, they could have an impact on the eventual outcome of the application.

This initial review does not address various public interest issues such as sensitive, threatened, or endangered fish species. These issues will be addressed as the Department reviews comments from the public and other agencies, and prepares a Proposed Final Order. If significant public interest issues are identified, they could have an impact on the eventual outcome of the application.

At this time, you must decide whether to proceed or to withdraw the application.

Proceed

If you choose to proceed with the application you do not have to notify the Department. The application will be placed on the Department's Public Notice to allow others the opportunity to comment. After the comment period the Department will complete a public interest review and issue a Proposed Final Order.

Withdraw

You may withdraw the application and receive a refund (minus a \$260 processing charge per application). You must notify the Department in writing by **Friday**, **January 19**, **2018**. For your convenience you may use the enclosed "STOP PROCESSING" form.

Initial Review Preliminary Determinations (OAR 690-310-0080)

- 1. Application G-18552 proposes the appropriation of 0.93 CFS of water from New Well 5 (POLK 53567/L113610), New Well 12 (POLK 53561/L113608), Well 27 (POLK 2883), and Well 28 in Hayden Lake Basin for irrigation of 74.3 acres March 1 through October 31; and the appropriation of 0.56 CFS of water from Well 7 (POLK 2791) for commercial uses September 1 through November 30.
- 2. The proposed use is not prohibited by law or rule except where otherwise noted below.
- 3. Irrigation and commercial uses are allowed under the Willamette Basin Program (Oregon Administration Rule (OAR) 690-502-0160). However, under OAR 690-502-0100, the use allowed from Well 28 is limited to November 1 through April 30 of each year.
- 4. Groundwater will likely be available within the capacity of the resource, and if properly conditioned (and if authorized), the proposed use of groundwater will avoid injury to existing groundwater rights.

- 5. The Department has determined, based upon OAR 690-009, that the proposed groundwater use from New Well 5 (POLK 53567/L113610), Well 7 (POLK 2791), and Well 27 (POLK 2883) will not have the potential for substantial interference with any surface water source.
- 6. The proposed groundwater use from New Well 12 (POLK 53561/L113608) will have the potential for substantial interference with Willamette River, and Well 28 will have the potential for substantial interference with Hayden Slough. Therefore, in accordance with OAR 690-400-0010(11)(a)(B), surface water availability must also be considered. Surface water from Willamette River is available during the full season requested; however surface water from Hayden Slough is not available during the period July 1 through September 30 of each year.
- 7. The proposed use is not located within or above any state or federal scenic waterway.
- 8. The points of appropriation are not located within a Critical, Limited or Withdrawn Groundwater Area.
- 9. Because this application will have an impact on surface water flows where the Oregon Department of Fish and Wildlife (ODFW) has identified that sensitive, threatened or endangered fish are present, this application will be reviewed by at least ODFW and the Department of Environmental Quality in accordance with OAR 690-033 rules. This review could have an impact on the eventual outcome of your application. This review could cause your application to be proposed for denial, the season of use to be shortened or impacted in some other way when the Department issues a proposed final order at the next stage of processing.
- 10. Documentation has been submitted from the relevant land-use planning jurisdiction that indicates the proposed use is allowed outright. ORS 537.621(3)(b); OAR 690-310-0150(2)(b)
- 11. The Department has determined that Well 27 (POLK 2883) and Well 28 do not meet current minimum well construction standards. The well log for Well 27 (POLK 2883) has no seal information and Well 28 has no well log, therefore the Department is unable to determine if the well is sealed adequately to comply with well construction standards. Although it is unlikely that a permit will be issued for Well 28, prior to the issuance of a permit for Well 27 (POLK 2883), evidence demonstrating compliance with well construction standards must be submitted and approved by the Department. In repairing the well(s), you should work closely with the Department and/or a licensed well constructor to ensure that repairs are carried out in a manner that will not violate well construction or other rules. You are encouraged to contact Joel Jeffery of the Department's Well Construction and Compliance Section at 503-986-0852 to determine how to proceed.

Please note that repair of the well(s) will not necessarily overcome the potential for substantial interference with surface water and may not result in the issuance of a permit.

Please also note that regardless of the outcome of this application, you will need to work with the Department to either repair or abandon the well(s) to comply with the minimum standards

for the construction, conversion, alteration, maintenance, and abandonment of water supply wells in order to protect the state's groundwater supply (OAR 690-200).

If a Permit is Issued it will Likely Include the Following Conditions:

- 1. Construction of the well shall begin within five years of the date of permit issuance. <u>The deadline to begin construction may not be extended.</u> This permit is subject to cancellation proceedings if the begin construction deadline is missed.
- 2. If the number, location, source, or construction of any well deviates from that proposed in the permit application or required by permit conditions, this permit <u>may not be valid</u>, <u>unless the Department authorizes the change in writing</u>.

3. Measurement Devices, and Recording/Reporting of Annual Water Use Conditions:

- A. Before water use may begin under this permit, the permittee shall install a totalizing flow meter at each point of appropriation. The permittee shall maintain the device in good working order.
- B. The permittee shall allow the watermaster access to the device; provided however, where any device is located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The permittee shall keep a complete record of the volume of water used each month, and shall submit an annual report which includes the recorded water-use measurements to the Department annually, or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water-use information, including the place and nature of use of water under the permit.
- D. The Director may provide an opportunity for the permittee to submit alternative measuring and reporting procedures for review and approval.

4. Annual Measurement Condition:

The Department requires the water user to obtain, from a qualified individual (see below), and report annual static water levels for each well on the permit. The static water level shall be measured in the month of March. Reports shall be submitted to the Department within 30 days of measurement.

The permittee shall report an initial March static water-level measurement once well construction is complete and annual measurements thereafter. Annual measurements are required whether or not the well is used. The first annual measurement will establish a reference level against which future measurements will be compared. However, the Director may establish the reference level based on an analysis of other water-level data. The Director may require the user to obtain and report additional water levels each year if more data are needed to evaluate the aquifer system.

All measurements shall be made by a certified water rights examiner, registered professional geologist, registered professional engineer, licensed well constructor or pump installer licensed by the Construction Contractors Board. Measurements shall be submitted on forms provided by, or specified by, the Department. Measurements shall be made with equipment that is accurate to at least the standards specified in OAR 690-217-0045. The Department requires the individual performing the measurement to:

- A. Associate each measurement with an owner's well name or number and a Department well log ID; and
- B. Report water levels to at least the nearest tenth of a foot as depth-to-water below ground surface; and
- C. Specify the method of measurement; and
- D. Certify the accuracy of all measurements and calculations reported to the Department.

The water user shall discontinue use of, or reduce the rate or volume of withdrawal from, the well(s) if any of the following events occur:

- A. Annual water-level measurements reveal an average water-level decline of three or more feet per year for five consecutive years; or
- B. Annual water-level measurements reveal a water-level decline of 15 or more feet in fewer than five consecutive years; or
- C. Annual water-level measurements reveal a water-level decline of 25 or more feet; or
- D. Hydraulic interference leads to a decline of 25 or more feet in any neighboring well with senior priority.

The period of restricted use shall continue until the water level rises above the decline level which triggered the action or the Department determines, based on the permittee's and/or the Department's data and analysis, that no action is necessary because the aquifer in question can sustain the observed declines without adversely impacting the resource or causing substantial interference with senior water rights. The water user shall not allow excessive decline, as defined in Commission rules, to occur within the aquifer as a result of use under this permit. If more than one well is involved, the water user may submit an alternative measurement and reporting plan for review and approval by the Department.

5. Well Identification Tag Condition:

Prior to using water from any well listed on this permit, the permittee shall ensure that the well has been assigned an OWRD Well Identification Number (Well ID tag), which shall be permanently attached to the well. The Well ID shall be used as a reference in any correspondence regarding the well, including any reports of water use, water level, or pump test data.

The water source identified in the application may be affected by an Agricultural Water Quality Management Area Plan. These plans are developed by the Oregon Department of Agriculture (ODA) with the cooperation of local landowners and other interested stakeholders, and help to ensure that current and new appropriations of water are done in a way that does not adversely harm the environment. APPLICATION PROCESS DESCRIPTION FOR GROUNDWATER, SURFACE WATER AND REGULAR RESERVOIR APPLICATIONS

In order to use the waters of Oregon, an application must be submitted and a permit obtained from the Water Resources Department. The water must be used for beneficial purpose without waste. For more information about water right topics, weekly public notice, forms and fees please visit our web site at **www.wrd.state.or.us**

1. Pre-application considerations

- Follow instructions in the application packet.
- If you have questions about completing an application or would like to arrange a preapplication conference contact the Department's Water Rights Customer Service Group at (503) 986-0801.

2. Application filing

- Application with fee is received by the Department.
- Department determines completeness of application.
- If <u>use</u> is not allowed by statute (ORS 538), the application and fees are returned to the applicant.
- An <u>incomplete</u> application and fees are returned to the applicant.
- Only a complete application receives a tentative priority date, is assigned a caseworker, and moves forward for processing.

3. Initial Review (IR)

- Caseworker reviews application by considering basin plans, water availability, statutory restrictions, and all other appropriate factors.
- Caseworker sends IR report to Applicant.
- Contact the Caseworker if you have questions about the IR.
- Four days after date of the IR, it is included in Department's weekly Public Notice.
- Public comments must be submitted within 30 days after the Public Notice.
- An administrative hold may be requested in writing by Applicant.

4. Proposed Final Order (PFO)

- Caseworker evaluates application against required criteria and develops draft permit, if appropriate.
- PFO includes instructions for filing of protests.
- Caseworker considers public comments and mails PFO to Applicant.
- The PFO is included in Department's weekly Public Notice.
- Public protests to the PFO must be submitted within 45 days after the Public Notice.

5. Final Order (FO)

• If no protest is filed, Final Order is issued.

The protest process

If one or more protests are filed, the process consists of:

- settlement discussion;
- contested case hearing;
- proposed Order;
- period of time to file exceptions; or
- Possible hearing by Water Resources Commission.
- Final Order is issued.

Permit holder responsibilities

- Comply with all water use conditions of the permit.
- Advise Department of address change or assignment to new permit holder.
- If need arises, request extension of time or authorize cancellation of permit.
- Submit timely claim of beneficial use (COBU) to the Department.
- Most permits require COBU to be prepared by a Certified Water Right Examiner.
- Permits may be canceled by the permit holder or by the Department for failure to comply with or one or more permit conditions.

Stop processing deadline is within 14 days of Initial Review - use the form below Applicant may request no further action and fee refund of all but \$260
