#### Appeal Rights

A request for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either file for judicial review, or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

#### Application History

Permit G-15158 was issued by the Department on August 15, 2002. The permit called for complete application of water to beneficial use by October 1, 2006. On September 30, 2016, Phillip and Lorissa Singhose submitted to the Department an Application for Extension of Time for Permit G-15158. In accordance with OAR 690-315-0050(2), on January 30, 2018, the Department issued a Proposed Final Order proposing to deny the time to fully apply water to beneficial use to October 1, 2021. The protest period closed March 16, 2018, in accordance with OAR 690-315-0060(1). No protest was filed.

## FINDINGS OF FACT

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated January 30, 2018.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, any comments received, and information within the file, the permit may not be extended.
