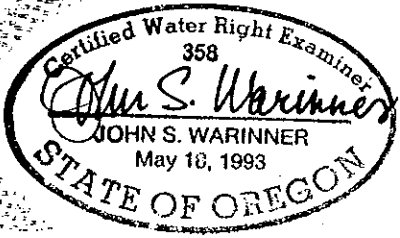

This letter is in regard to your water use Permit G-11708. As we pointed out to you in our letter of January 15, 1997, your claim of beneficial use must be received in this office by **October 1, 1997**.

Oregon Administrative Rule 690-14-190 states: "The claim of beneficial use shall be submitted to the Department within one year after the use was reported..as being complete...Failure to comply with this section shall cause the Director to initiate permit cancellation proceedings as provided by ORS 537.260."

The "claim" consists of a site report and map of the developed use prepared by a Certified Water Rights Examiner, which accompany a request from the permittee for issuance of a certificate of water right.

You are hereby notified that unless your claim is received on or before **October 1, 1997**, your permit will be canceled without further notice.

The date for the complete application of water to a beneficial use for your water use Permit G-11708 was October 1, 1996. To date we have not received notice that your project was completed.

If the project was completed, you should promptly submit the notice of complete application of water. If you were unable to complete the project within the time allowed, you may wish to request an extension of the time limits. Forms will be furnished upon request.

In order to obtain a certificate of water right, you are required by law to hire a certified water right examiner to conduct the final proof survey of the completed use. This must be done within one year after the use is reported as being complete or within one year after the beneficial use date allowed in the permit, whichever occurs first. Accordingly, the map and claim of beneficial use must be received in this office on or before **October 1, 1997**. A list of certified water right examiners is enclosed for your information.

Upon receipt of the map and claim of beneficial use, the information will be reviewed and a brief field inspection may be conducted by a representative of this office. Following that, a proposed certificate of water right will be mailed to you for review.

If you are no longer interested in the project, please let us know. We will provide forms for you to authorize the cancellation of the permit.

Dear Permit Holder:

Within the last two years you were issued a permit to appropriate groundwater from this office. As a condition of the permit, you are to obtain a static water level measurement and submit the measurement to this office on a prescribed basis.

The permit condition failed to include licensed well constructors or pump installers licensed by the Construction Contractors Board as authorized individuals to make these measurements. This letter is to clarify that these additional parties are authorized to perform the water level measurements.

When your project is completed and the claim of beneficial use is submitted, the condition will be corrected when the resulting water right certificate is issued.

Permit condition describing licensed well constructor or pump installer licensed by the Construction Contractors Board as authorized agents of the permittee:

The permittee shall obtain a static water-level measurement for each well during March of each year and report the measurement to the Department within thirty days. The measurement shall be made by a certified water-rights examiner, registered professional geologist, certified engineering geologist, professional engineer, licensed well constructor or pump installer licensed by the Construction Contractors Board.
