- 1. On September 14, 2017, Bryan Schurter and Amy Shurter submitted an application to the Department for a water use permit.
- 2. The Department issued a Proposed Final Order on June 5, 2018.
- 3. The protest period closed July 20, 2018, and no protest was filed.
- 4. The proposed use would not impair or be detrimental to the public interest.

CONCLUSION OF LAW

1. The conclusions of law in the Proposed Final Order issued June 5, 2018 are incorporated herein.

Appeal Rights

This is a Final Order in other than contested case. This order is subject to judicial review under ORS 536.075 and ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to OAR 137-004-0080 you may petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

NOTE: When issuing permits, ORS 537.628(1) authorizes the Department to include limitations and conditions which have been determined necessary to protect the public welfare, safety, and health. Permit G-18093 is conditioned accordingly.
