Summary: Order approving Application G-18329 and issuing Permit G-17998.

### Authority

This Final Order is issued pursuant to ORS 537.625 and OAR 690-310-0200.

#### FINDINGS OF FACT

The findings of fact in the Proposed Final Order issued January 30, 2018 are incorporated herein.

- 1. On June 30, 2016, Robinson Farm LLC and Chris Robinson submitted an application to the Department for a water use permit.
- 2. The Department issued a Proposed Final Order on January 30, 2018.
- 3. The protest period closed March 16, 2018, and no protest was filed.
- 4. The proposed use, as conditioned, will ensure the preservation of the public welfare, safety and health.

#### **CONCLUSIONS OF LAW**

The conclusions of law in the Proposed Final Order issued January 30, 2018 are incorporated herein.

When issuing permits, ORS 537.628(1) authorizes the Department to include limitations and conditions which have been determined necessary to protect the public welfare, safety, and health. The Permit G-17998 is conditioned accordingly.

#### Appeal Rights

This is a Final Order in other than contested case. This order is subject to judicial review under ORS 536.075 and ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to OAR 137-004-0080 you may petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
