Summary: Order approving Application S-86764 and issuing Permit S-55157.

Authority

The application is being processed in accordance with Oregon Revised Statute (ORS) 537.153 through 537.175, and 390.826, and Oregon Administrative Rule (OAR) Chapter 690, Divisions 5, 33, 300, 310, 400, 410, and Willamette Basin Program OAR 690-502. This Final Order is issued pursuant to ORS 537.170(6) to (9) and OAR 690-310-0170 to 0190.

FINDINGS OF FACT

The findings of fact in the Proposed Final Order issued May 29, 2018 are incorporated herein with the following modification:

- 1. On February 9, 2007, Roserock West 1 LLC and Roserock West 2 LLC submitted an application to the Department for a water use permit.
- 2. The Department issued a Proposed Final Order on May 29, 2018.
- 3. The protest period closed July 13, 2018, and no protest was filed.
- 4. The Department's continuing evaluation reveals that the following corrections to the Proposed Final Order and draft permit are necessary to accurately reflect the applicant's water use permit application:
 - a. The total acreage proposed for primary irrigation is 29.68 acres, as described in the attached permit.

Hearing Rights

Under the provisions of ORS 537.170 and ORS 537.622, the applicant may request a contested case hearing by submitting the information required for a protest under ORS 537.153(6) or ORS 537.621(7) to the Department within 14 days after the date of mailing of this order as shown below. If a contested case hearing is requested, the Department must schedule one. In the contested case hearing, however, only those issues based on the modifications to the Proposed Final Order may be addressed. Only the applicant or protestant may appeal this order. (ORS 537.170(7)(b).

Appeal Rights

This is a Final Order in other than contested case. This order is subject to judicial review under ORS 536.075 and ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to OAR 137-004-0080 you may petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

b. The Proposed Final Order and draft permit erroneously stated the incorrect priority date. The priority date is corrected to read February 9, 2007, as stated in the attached permit

CONCLUSIONS OF LAW

- 1. The conclusions of law in the Proposed Final Order issued May 29, 2018 are incorporated herein, with the above modifications.
- 2. The proposed use would not impair or be detrimental to the public interest.

NOTE: When issuing permits, ORS 537.170(6) authorizes the Department to include provisions or restrictions concerning the use, control and management of the water to be appropriated for the project. Permit S-55157 is conditioned accordingly.

<u>ORDER</u>

Application S-86764, as amended, is approved and Permit S-55157 is issued.
