Dear Oregon Department of Fish and Wildlife:

**THIS IS NOT A WATER RIGHT CERTIFICATE
AND IS SUBJECT TO CHANGE AT THE NEXT PHASE OF PROCESSING**

This letter is to inform you of the preliminary analysis of your water right application. This document, called an "Initial Review", is to inform you of the potential limitations to your proposed instream water right and to describe some of your options. Based on the information you have provided, the Water Resources Department has made the following preliminary determinations:

Please reference the application number when sending correspondence regarding conclusions of this Initial Review. Comments received within the comment period will be evaluated at the next phase of the process.

Initial Review Determinations:

1. The referenced application is complete and not defective. The proposed use is not prohibited, restricted or limited by law except for water availability limitations in certain months as depicted below.
2. The reach proposed in this application for an instream water right is in the Mid Coast Basin.
3. The instream fish life uses and wildlife use are allowed under the Mid Coast Basin Program OAR (690-518-0010(1))
4. Water allocable for instream use is limited to the estimated average natural flow. Specifically, (OAR 690-077-0015(4) states "If natural streamflow or natural lake levels are the source for meeting instream water rights, the amount allowed during any identified time period for the water right shall not exceed the estimated average natural flow or level occurring from the drainage system except where periodic flows that exceed the natural flow or level are significant for the applied public use".
5. All amounts of water identified in this document are in cubic feet per second.

Summary of Determination:

6. Some percentage of the water applied for has been determined allowable for the purpose identified in the application. The amount of water allowable for instream use is shown in the table below.

Five Rivers, tributary to Alsea River, beginning just below the confluence with Lord Creek at river mile 19.1 (SWNW, S27, T15S, R9W, WM) in Lane County (44.240131, -123.771249) and continuing downstream to just above the confluence with Green River at river mile 14.9 (SESE, S8, T15S, R9W, WM) in Lane County (44.274839, -123.797411).

Following evaluation of the comments, the department issues a proposed final order. Issuance of the proposed final order includes a 45 day protest period.

Withdrawal:

If you choose not to proceed, you may withdraw your application. To accomplish this you must notify the Department in writing by February 5, 2019.

To Proceed with Your Application:

If you choose to proceed with an application, you do not have to notify the Department. Your application will automatically be placed on the Department's Public Notice to allow others the opportunity to comment. After the comment period the Department will complete a public interest review and issue a proposed final order.
