

To establish a new vineyard, irrigation is typically applied during the initial growing seasons for the young, newly transplanted grape vines. Once the vines get fully established, little or no irrigation is normally required to produce wine grapes of quality in desired quantity.

Drip irrigation is the most suitable and desirable for this purpose. Drip irrigation maximizes the delivery of water to the young vines and minimizes undesirable needs. Well-monitored drip irrigation also maximizes the efficient delivery of water as needs change over time, and avoids all danger of contamination of any nearby stream.

If you sign the receipt, you will have 30 days from the Water Resources Department's notice date to return the completed Land Use Information Form or WRD may presume the land use associated with the proposed use of water is compatible with local comprehensive plans.

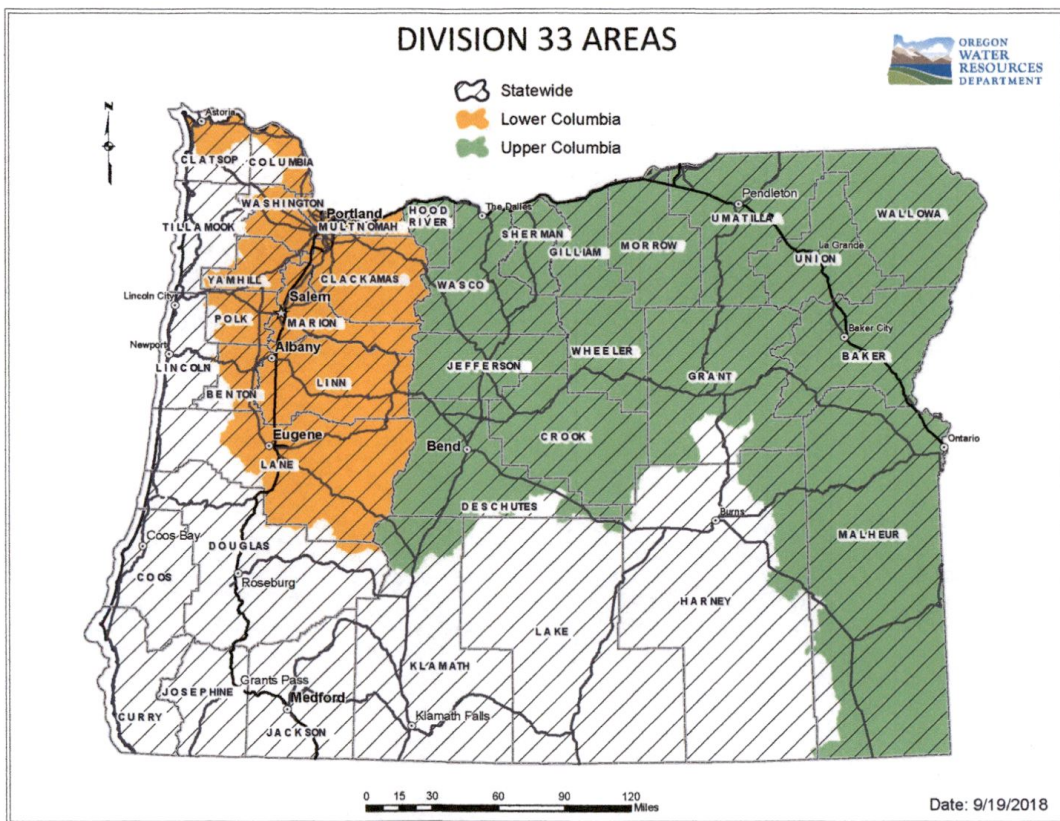
