A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

Permit G-15991 was issued by the Department on December 2, 2005. The permit specified complete application of water to beneficial use by October 1, 2010. On March 19, 2019, Steve Janac, agent for Midstate Electric Cooperative, Inc. submitted an Application for Extension of Time for Permit G-15991. In accordance with OAR 690-315-0050(2), on May 7, 2019, the Department issued a Proposed Final Order proposing to the time to fully apply water to beneficial use to March 12, 2019. The protest period closed June 21, 2019, in accordance with OAR 690-315-0060(1). No protest was filed.

FINDINGS OF FACT

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated May 7, 2019.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, any comments received, and information within the file, the permit may be extended subject to no additional conditions.

CONCLUSION OF LAW

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.630, 539.010(5) and OAR 690-315-0040(2).

ORDER

The extension of time for Application G-16294, Permit G-15991, therefore, is approved. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2010, to March 12, 2019.
