This Is to Certify, That Augustine J. Kirsch and Marie A. Kirsch
of Route 1, Box 113, Stayton, State of Oregon, has a right to the use of

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Marion County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 14, at page 354; that the priority of the right thereby
confirmed dates from 1869; for domestic; and shall be subject to the provisions
of paragraph 165 of said decree for stock use with no diversions;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall ~~not be~~ be subject to the pro-
visions of Paragraph 165 of said decree;
