of Route 1, Box 835, Elk Creek Road, Trail, State of Oregon, has applied beneficially the waters of Sugar Pine Creek and Elk Creek

a tributary of Rogue River for the purpose of irrigation of 26.5 acres

under Permit No. 26109 of the State Engineer, and that the use of said waters has been completed under the terms of said permit; that the priority of the right dates from April 8, 1959

that the amount of water for the purposes aforesaid, has been actually beneficially used in the amount of 0.33 cubic foot per second, being 0.24 c.f.s. from Sugar Pine Creek and 0.09 c.f.s. from Elk Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, SW 1/4 NE 1/4, SE 1/4 NE 1/4, NE 1/4 SE 1/4, SW 1/4 SE 1/4, Section 14, NW 1/4 NE 1/4, NW 1/4 SW 1/4, Section 23, SW 1/4 NE 1/4, Section 27, T. 32 S., R. 1 E., W. M., Portable Pumping along Sugar Pine Cr. from a point 320 feet South \*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
