Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

## **Application History**

Permit S-54642 was issued by the Department on March 31, 2010. The permit specified completion of construction, and complete application of water to beneficial use by, May 31, 2015. On June 24, 2019, Silvies Valley Ranch, LLC submitted an Application for Extension of Time for Permit S-54642. In accordance with OAR 690-315-0050(2), on August 6, 2019, the Department issued a Proposed Final Order proposing to extend the time to complete construction from May 31, 2015, to October 1, 2021, and the time to apply water to full beneficial use from May 31, 2015, to October 1, 2021. The protest period closed September 20, 2019, in accordance

with OAR 690-315-0060(1). No protest was filed.

#### FINDINGS OF FACT

The Department adopts and incorporates by reference the findings in the Proposed Final Order dated August 6, 2019.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, the permit may be extended subject to the following conditions:

### **CONCLUSION OF LAW**

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.230, 539.010(5) and OAR 690-315-0040(2).

### **ORDER**

The extension of time for Application S-87463, Permit S-54642, therefore, is approved. The deadline for completing construction is extended from May 31, 2015, to October 1, 2021. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from May 31, 2015, to October 1, 2021.
